


MATERIAL FACT - PRELIMINARY OPERATING RESULTS 1Q23

São Paulo, April 26, 2023 – ALLPARK EMPREENDIMENTOS, PARTICIPAÇÕES E SERVIÇOS S.A. ("Company" or "Estapar"), in compliance to CVM Resolution No. 44, dated as of 2021, as well as with the Novo Mercado Rules, informs its shareholders and the general market its 1023 Preliminary Operating Performance. We emphasize that the information disclosed below is preliminary, non-audited and subject to revision.

ALL-TIME HIGH NET REVENUE




New historical record of Estapar's Net Revenue, due to the organic and newly invested businesses growth

Net Revenue totaled **R\$305.5** million in 1Q23 (+25.2% vs. 1Q22). Growth was due to higher vehicle flow in our operations in Commercial Buildings, Shopping Malls, and Arenas, and the offering of new products and services in our digital platforms, such as App Zul+.

DIGITAL PLATFORMS (1)

The share of revenue from digital platforms continues growing, reaching **16.6**% of total revenue for 1Q23 (+**2.1** p.p. vs. 1Q22).

The number of users registered in our digital platforms exceeded **8.0 million**, who, in addition to using our parking and street parking (zona azul) products and services, contributed to the higher sales of products and services offered by App Zul+, a platform that offers auto insurance, Tag, payment of IPVA and fines, among other products and services.




PARKING SPACES

of parking spaces at the end of the period (thousand of parking spaces)

In 1Q23, we started operating in 15 new parking lots, in 11 cities, especially in the Healthcare and Shopping Malls segments.

Net increase of parking spaces of 13.7% compared to the previous year, totaling 441.1 thousand parking spaces. The total considers 67.6 thousand parking spaces from CAD Accreditation operations (purchase and sale of Zona Azul tickets) from the acquisition of Zul Digital in April 2022⁽²⁾.

CHURN (3)



At the end of 1Q23, Churn reached 0.10%, below the historical levels. In 1Q23, the decrease in Churn was a result of our focus on Estapar's commercial expertise in contract renewals, aiming at a portfolio of increasingly profitable contracts.
