ECORODOVIAS INFRAESTRUTURA E LOGÍSTICA S.A. ("Company" or "Ecorodovias") hereby informs its shareholders and the market, due to the Covid-19 pandemic, its preliminary consolidated monthly traffic numbers for June 2021 and for the year to June 30, which include comparisons with the same periods of 2020 and 2019. The results presented herein are managerial and subject to review.

Starting from this date, the Company will disclose comparative traffic figures on a monthly basis.
