ECORODOVIAS INFRAESTRUTURA E LOGÍSTICA S.A. (“Company” or “Ecorodovias”) hereby informs its shareholders and the market, due to the Covid-19 pandemic, its preliminary consolidated monthly traffic numbers for September 2021 and for the year to September 30, which include comparisons with the same periods of 2020 and 2019.
