**ECORODOVIAS INFRAESTRUTURA E LOGÍSTICA S.A.** (“Company” or “EcoRodovias”) hereby informs its Shareholders and the market, the preliminary consolidated traffic monthly figures for September 2022 and the first nine months of 2022 in relation to the same periods in 2021. These are managerial results and are subject to change.

EcoRioMinas started collecting tolls at the Engenheiro Pierre Berman, Santa Guilhermina and Santo Aleixo toll plazas, which jointly account for approximately 34% of total toll revenue of the concessionaire. EcoRioMinas manages the BR-116/465/493/RJ/MG highways, including the Metropolitan Arch of Rio de Janeiro and the stretch of Serra de Teresópolis, totaling 726.9 km in length.

Note: Equivalent paying vehicle is a basic unit of reference in toll collection statistics on the Brazilian market. Light vehicles, such as automobiles, correspond to an equivalent vehicle unit. Heavy vehicles such as trucks and buses are converted to equivalent vehicles by a multiplier applied to the number of axles per vehicle, as established in the terms of each concession agreement. The results are managerial and subject to review.

The Company reaffirms its commitment to its obligations as a publicly-held company listed on the Novo Mercado segment of the B3 stock exchange and will disclose all and any material information in accordance with applicable legislation.
