

Banco Bradesco S.A. (Company) informs its shareholders and the market in general that the Board of Directors, in a meeting held today, approved proposal of the Company's Board of Executive Officers, for payment of supplementary interest on shareholders' equity, in the total amount of **R\$5,926,000,000.00**, being **R\$0.530368815** per common share and **R\$0.583405697** per preferred share, which will benefit the shareholders who are registered in the Company's records on January, 6, 2023, (entitlement base date), with the shares being traded "ex- supplementary interest on shareholders' equity" as of January, 9, 2023.

The payment:

- will be in March, 8, 2023, by the net amount of **R\$0.450813493** per common share and **R\$0,495894842** per preferred share, considering the withholding income tax deduction of fifteen percent (15%), except for the legal entity shareholders who are exempt from such taxation, who will receive by the declared amount.
- will be done as follows:
  - a) to the shareholders whose shares are deposited at the Company and who keep their register and banking data updated, by means of credit in the current accounts in a Financial Institution appointed by them; and
  - b) to the shareholders whose shares are deposited at B3 S.A. - Brasil, Bolsa, Balcão, by means of Institutions and/or Brokerage Houses which keep their shareholding position in custody.

The shareholders who do not have their data updated must go to a Bradesco Branch of their preference, with their Individual Taxpayer's ID, Identification Document and proof of residence to update their information and receive the respective amounts to which they are entitled.
