**MATERIAL FACT**

**GETNET ADQUIRÊNCIA E SERVIÇOS PARA MEIOS DE PAGAMENTOS S.A.** ("Getnet" or "Company"), in compliance with article 157 of Law No. 6,404/76 and Brazilian Securities Commission ("CVM") Ruling No. 23/2021, informs its shareholders and the market in general, that on September 17, 2021, its Executive Board approved the restatement of its financial statements under IFRS for the fiscal years ended December 31, 2020, 2019 and 2018 ("Financial Statements") and its Quarterly Information (*Informações Trimestrais – ITR*) under IFRS for the three (3)-month periods ended March 31 and June 30, 2021 ("ITRs" and "Restatement", respectively).

The Restatement occurred as a result of requirements made in connection with the Getnet's registration proceeding with the United States Securities and Exchange Commission ("SEC").

There was no change to the assets, liabilities and equity balances, as well as to the net income, when compared to the previously approved statements.

The implemented changes consider the reclassification of certain expenses that were previously classified as "Selling, General and Administrative Expenses" and are now being reclassified to "Costs of services" in our "Statements of Income" and in our "Value Added Statements" (*Demonstrações do Valor Adicionado*). The reclassified values and respective information on changes can be found in Note 1 to the restated Financial Statements and ITRs.

The restated Financial Statements and ITRs were subject to the audit and limited review, respectively, of *PricewaterhouseCoopers Auditores Independentes*.

In order to allow investors to properly understand the financial information, the Company filed a new version of the Reference Form (*Formulário de Referência*) related to the year 2020 on this date, reflecting the changes made in the resubmission.

The Company informs that, as of this date, the restated Financial Statements (including the Standardized Financial Statements), ITRs and Reference Form are available to shareholders, at the head office of Getnet and on the websites of the Brazilian Securities Commission (CVM) ([www.cvm.gov.br](http://www.cvm.gov.br)) and of B3 SA – Brasil, Bolsa, Balcão ([www.b3.com.br](http://www.b3.com.br)), as well as on the Company's investor relations website ([ri.getnet.com.br](http://ri.getnet.com.br)).
