## NOTICE TO THE MARKET

CCR S.A. ("CCR" or "Company") (B3: CCRO3; Bloomberg: CCRO3BZ; Reuters: CCRO3.SA), following up on Notice to Market on December 02, 2021 given the position adopted by the Company to issue a monthly newsletter, on its website, to provide information on the flow in concessions under CCR's management announces to its shareholders and the market in general, the consolidated result of the survey referring to highway traffic as equivalent vehicles, urban mobility as passengers transported, airports as passengers boarded, all shown in the newsletter from **November**, the comparisons were made between the same periods of the years 2021, 2020 and 2019, as follows:



### TOLL ROADS - YoY



## TOLL ROADS - YoY


equivalent vehicles

## MOBILITY - YoY


passengers transported
