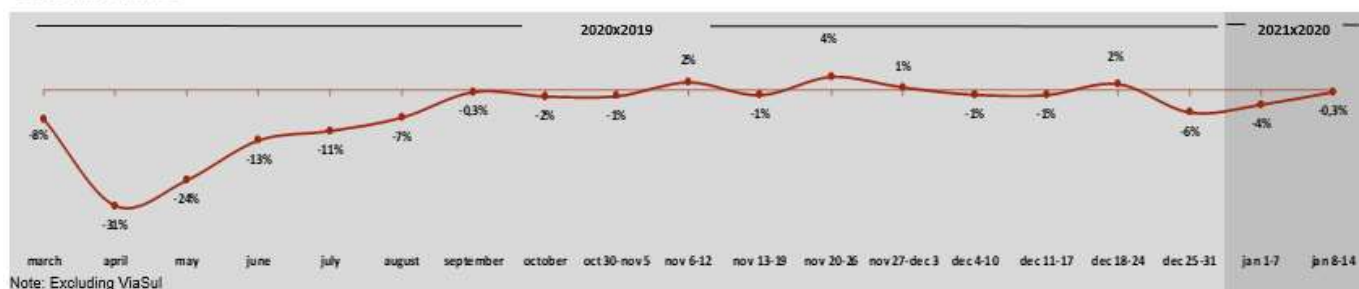

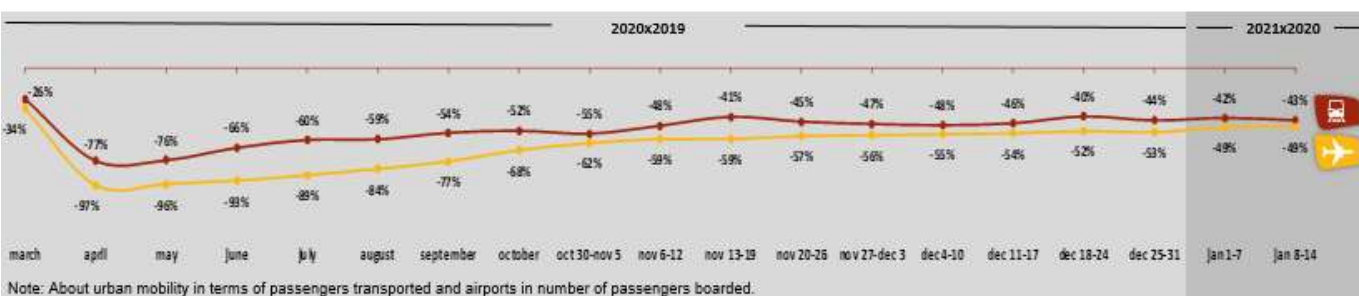
HIGHWAYS - YoY
