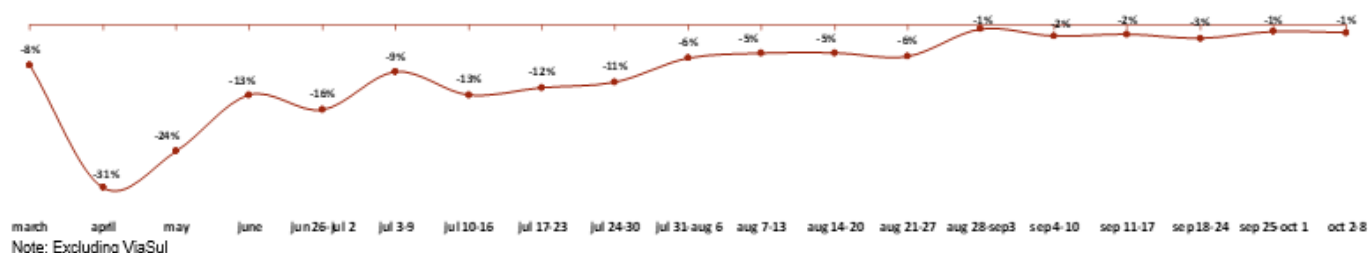

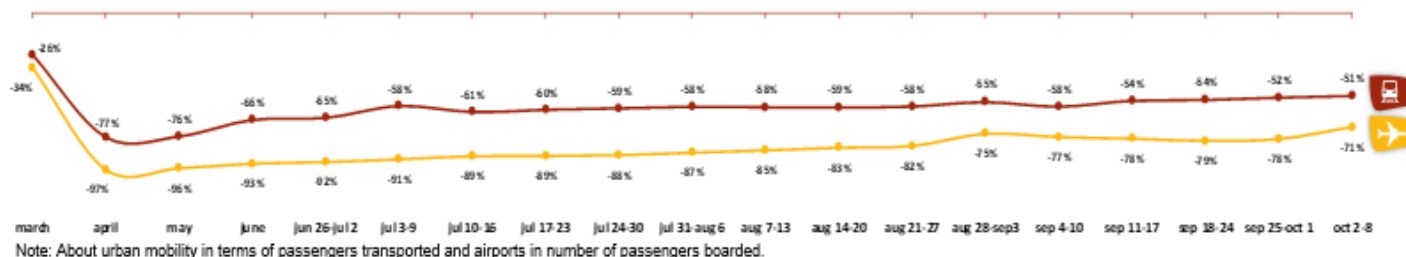
HIGHWAYS - (2020 vs 2019)
