NOTICE TO THE MARKET

CCR S.A. ("CCR" or "Company") (B3: CCRO3; Bloomberg: CCRO3BZ; Reuters: CCRO3.SA), following up on the Material Facts disclosed on March 18, 2020, and March 21, 2020, and given the position adopted by the Company to issue a weekly newsletter, on its website, to provide information on the flow in concessions under CCR's management, in an aggregated manner by Division (Infra SP, LAM Vias, Mobility and Airport), announces to its shareholders and the market in general, the consolidated result of the survey referring to highway traffic as equivalent vehicles, urban mobility as passengers transported, airports as passengers boarded, all shown in the weekly newsletter from December 11, 2020, to December 17, 2020, as follows:

It is worth mentioning that, due to our end-of-the-year recess, traffic data for the periods from December 18 to 24, 2020, and from December 25 to 31, 2020, will be disclosed to the market on January 5, 2021.







