NOTICE TO THE MARKET

CCR S.A. 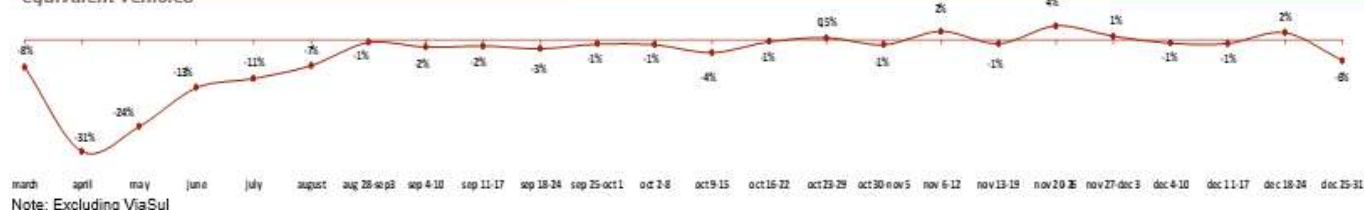

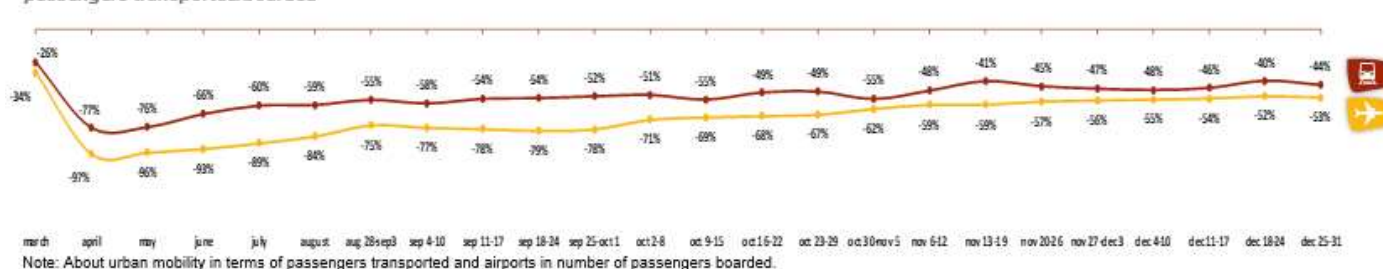
HIGHWAYS - (2020 vs 2019)
