NOTICE TO THE MARKET**CONCLUSION OF THE CONCILIATION PROCEEDING BEFORE THE TCE-MG**

Companhia de Saneamento de Minas Gerais - COPASA MG (B3: CSMG3) (“Company” or “COPASA-MG”), further to the [Notice to the Market released by the Company on August 08, 2025](#), hereby informs that, on this date, the conciliation and conflict prevention proceeding established before the Court of Accounts of the State of Minas Gerais (“TCE-MG”) was concluded.

The purpose of the conciliation proceeding was to seek mutual understanding and resolve matters related to the New Legal Framework for Basic Sanitation regarding the possibility of expanding the concession and program agreements executed between the Company and 273 municipalities in the State of Minas Gerais, currently intended exclusively for the provision of water supply services, to also include sewage services, without the need for a prior bidding process.

At the conclusion of the conciliation proceedings, COPASA-MG and the Minas Gerais Municipalities Association (AMM), by mutual agreement, submitted a settlement agreement proposal. The instrument acknowledges the legal possibility of such contractual expansion through the execution of replacement agreements or amendments, according to the specific characteristics of each municipality.

The decision to adhere to the agreement rests exclusively with each municipality. The inclusion of sewage services is subject to the economic and financial rebalancing of the agreements, to be achieved through the extension of their terms.

The settlement agreement will be submitted to the Technical Unit of the TCE-MG and to the Public Prosecutor’s Office attached to the Court of Accounts for review, and subsequently to the Court’s Full Bench for deliberation, which is a necessary condition for the agreement to become fully effective.
