The Institutional and Governmental Relations (RIG) department at Dexco is responsible for leading strategic initiatives in public policy, always aligned with the company's business interests. The team works in a structured manner to monitor the legislative and regulatory landscape, helping ensure that public entities have access to qualified, data-driven information to support policy formulation and decision-making.

The department's conduct is guided by the highest standards of ethics, transparency, and integrity, in strict compliance with applicable laws and the Company's Anti-Corruption Policy. Accordingly, and in line with internal policies (the Anti-Corruption Policy and the Internal Donations Standard), **Dexco does not make political contributions.**

In line with the Company's strategic positioning, **Dexco actively participates in 34 industry institutions and associations**, collaborating with these entities to represent the interests of the sectors in which it operates. In 2024, the RIG team stood out for its strategic efforts on several key fronts, notably **advancing discussions on the regulated carbon market in Brazil** – aligned with the environmental commitments of the Paris Agreement – as well as actively participating in debates on tax reform, environmental regulations, and labor-related matters.
