NOTICE TO SHAREHOLDERS

Companhia de Saneamento Básico do Estado de São Paulo – Sabesp ("**Company**" or "**Sabesp**"), hereby informs its shareholders and the market in general that, at a meeting of the Board of Directors held on March 16, 2026, the Board has approved, among other matters, the payment of interest on equity, to shareholders holding shares issued by the Company on the base date of March 19, 2026 ("**JCP**").

I. AMOUNT, DATE AND TERMS OF CREDIT AND PAYMENT

Interest on equity will total the gross amount of R\$ 583,562,521.95 (five hundred eighty-three million, five hundred sixty-two thousand, five hundred twenty-one reais and ninety-five cents), corresponding to R\$0.83342453884 per share, to be paid on April 30, 2026.

The total gross amount of interest on equity herein credited will be imputed and will deduct the amount of mandatory dividends for the fiscal year ending on December 31, 2025, subject to the provisions of the Company's Dividend Distribution Policy and will not be subject to monetary adjustment.

Shareholders who are part of the Company's shareholder base at the end of the trading session on March 19, 2026 will be entitled to the interest on equity hereby credited. The shares issued by the Company will be traded "*ex-proceeds*" on B3 S.A. – Brasil, Bolsa, Balcão as of March 20, 2026 (inclusive).

II. WITHHOLDING INCOME TAX

Income tax will be withheld from the amount declared to shareholders in the form of JCP, in accordance with current legislation, except for immune or exempt shareholders who prove this condition by March 30, 2026, and the corresponding documents must be sent to the Company's headquarters, at Rua Costa Carvalho, 300 – Office 265 – São Paulo – SP – CEP 05429-900, in attention to the Fundraising and Investor Relations Office or to the electronic address sabesp.ri@sabesp.com.br.

III. INSTRUCTIONS ON CREDIT AND PAYMENT OF INTEREST AS REMUNERATION ON EQUITY

Shareholders shall have their credits available on the date of payment of this right, as set forth in item I above, according to their bank account and bank domicile provided to Itaú Corretora de Valores S.A.



To shareholders whose registration does not contain the number of enrollment with the CPF/CNPJ or information of Bank/Branch and bank account, the interest will be credited, in compliance with item I above, as of the third business day counted from the date of the registration update in the electronic files of Itaú Corretora de Valores S.A. This update may be made through any branch of the bank.

More information shall be obtained from Itaú bank branches during banking hours.
