**NOTICE TO SHAREHOLDERS**  
**DIVIDENDS AND INTEREST ON NET CAPITAL PAYMENT DELIBERATION**

At a meeting of the Board of Directors of CSN Mineração S.A. ("Company") held on this date, it was approved, pursuant to article 30 of its Bylaws, as an anticipation of the minimum mandatory dividend, the distribution of R\$ 1,300,000,000.00 (one billion and three hundred million reais) to the profit reserve account, of which:

- (a) R\$ 1,090,000,000.00 (one billion and ninety million reais) as interim dividends, corresponding to the amount of R\$ 0.200661094064 per share; and
- (b) R\$ 210,000,000.00 (two hundred and ten million reais) as payment by the Company of interest on equity, corresponding to the amount of R\$ 0.0386594768380 per share, and with the exception of immune and exempt shareholders, this amount is subject to income tax at source at the rate of 15% (fifteen percent), except for the application of this rate to shareholders domiciled in a country that does not tax income or that taxes it at a maximum rate lower than twenty percent (20%) which, in this case, are subject to the incidence of income tax at source at the rate of twenty-five percent (25%), as provided for in article 8 of Law No. 9,779/99. Considering the rate of 15% (fifteen percent), the net amount of Income Tax to be paid will be R\$ 0.032860555312 per share.

Shareholders registered with the depositary institution, Banco Bradesco S.A., on May 13, 2025, are entitled to receive these dividends and interest on equity and, as of May 14, 2025, the shares will be traded ex-dividends/ex-rights over interest on net equity

The payment of interim dividends and interest on equity will be made by December 31, 2025, on a specific date(s) to be timely informed to the Shareholders and the market, without the application of monetary adjustment or incidence of interest between the date of declaration and the date(s) of the effective payment(s).

Shareholders using fiduciary custody will have their dividends and interest on equity credited according to procedures adopted by the Stock Exchanges.

Shareholders whose registration does not include the registration of the CPF/CNPJ number or the indication of the "Bank/Agency/Current Account", will have their interest on equity credited within three (3) business days from the due regularization of the respective registrations at the branches of Banco Bradesco S.A., by filling out the "Investor Registration

Form", which will be sent by the agency to the Department of Actions and Custody.

Dividends not claimed within three (3) years from the date of commencement of payment shall expire and revert to the Company (Law No. 6,404/76, article 287, item II, item a).
