MINUTES OF THE ANNUAL GENERAL MEETING HELD ON THE 8th OF APRIL OF 2022

I. Date, Time, and Place: The 8th of April, 2022, at 10:00 am, at the registered office of Marfrig Global Foods S.A. ("Company"), located at Avenida [Avenue] Queiroz Filho, nº 1560, Bloco 5, Torre Sabiá, 3º andar, Sala 301, Vila Hamburguesa, City of São Paulo, State of São Paulo, CEP [Zip code] 05319-000.

II. Call: Call Notice published in the editions of the 9th, 10th, and 11th of March, 2022, of *Jornal Valor Econômico*, in their physical (pages A-10, A-6 and A-14) e digital versions. The documents required by CVM Instruction No. 481/2009 have also been electronically disclosed to the market.

III. Publications: Annual Management Report, Financial Statements pertinent to the fiscal year ended on the 31st/12/2021, followed by Explanatory Notes, Summary Annual Report of the Statutory Audit Committee, and Opinions of Grant Thornton Auditores Independentes, of the Fiscal Council, and of the Audit Committee were published in the edition of the 31st of March, 2022 in the digital and physical versions (pages G25 to G37) of the Jornal Valor Econômico.

IV. Attendance: Shareholders representing 73,58% of the Company's voting and total capital stock were in attendance, as per the signatures which read in the Shareholders' Attendance Book. In Attendance: member of the Administrative Board of the Company, Mr. Heraldo Geres - Legal and HR Vice-President; Mr. Eduardo Augusto Rocha Pocetti - member of the Board of Auditors; Mr. Antonio dos Santos Maciel Neto - coordinator of the Statutory Audit Committee; and Messrs. Jefferson Coelho Diniz and Raphael Tonetto Rodrigues - representatives of Grant Thornton Auditores Independentes.

V. Meeting Board: Chairman: Mr. Heraldo Geres; Secretary: Mr. Ricardo Araújo Rocha.

VI. Agenda: (I) Take accounts from the administrators, examine, discuss, and vote on the Financial Statements for the fiscal year ended on the 31st/12/2021; **(II)** Elect the members to compose the Board of Auditors; **(III)** Set the global compensation of the members of the Board of Directors, Statutory Board of Executive Officers, and Board of Auditors for the year 2022; and **(IV)** Decide on the allocation of net income and distribution of dividends.

VII. Resolutions: The following resolutions were taken, with the abstention of those legally impeded, abstentions, and orientation of votes received at the Meeting, including by means of

the remote voting ballots, the drawing up of these minutes having been authorized in the form of a summary and publication of the same with omission of the signatures of the shareholders in attendance, as permitted by article 130, §§ 1 and 2, of Law No. 6.404/76 ("Lei das S.A.") [Joint-Stock Company Law]:

(I) Approve, **by majority** of the shareholders in attendance, with appraisal of 69,66% of votes in favor, represented by por 343,741,740 shares; 0.09% of votes against, represented by 617,700 shares; and 3.82% abstentions, represented by 25.232.520 shares, without reservations, the accounts of the Administrators and the Financial Statements for the fiscal year ended on the 31st of December, 2021, followed by the Explanatory Notes, the opinion of Grant Thornton Auditores Independentes, and the opinions of the Board of Auditors and the Statutory Audit Committee of the Company;

(II) Elect, by majority of the shareholders in attendance, the persons indicated below, to compose the Board of Auditors of the Company, who shall take their respective offices upon signature of the respective Instruments of Investiture, for a term of office of 1 (one) year, ending at the Annual General Meeting to be held in 2023. Elected as full members of the Board of Auditors, Messrs. Ricardo Florence dos Santos, Brazilian, married, chemical engineer, holder of Identity Card RG nº 6.231.779-9 - SSP/SP, enrolled with the CPF/MF [Individual Taxpayer's Registry] under nº 812.578.998-72; José Luiz De Souza Gurgel, Brazilian, married, economist and accountant, holder of identity card RG nº 07039783-1 DETRAN RJ, enrolled with the CPF/MF under nº 918.587.207-53; and Axel Erhard Brod, German, divorced, business administrator, holder of Identity Card RNE W432250-Z DPF/RJ and enrolled with the CPF/MF under nº 787.729.907-91, all of whom with domicile at Av. [Avenue] Queiroz Filho, nº 1560, Bloco 5, Torre Sabiá, 3º Andar, Vila Hamburguesa, City of São Paulo, State of São Paulo -CEP 05319-000. Have been elected, as alternate members, Messrs. José Osvaldo Bozzo, Brazilian, married, lawyer, holder of Identity Card RG nº 15.644.093-3 SSP/SP, enrolled with the CPF/MF under nº 052.238.968-66; Ely Carlos Perez, Brazilian, married, accountant, holder of Identity Card RG nº 18.641.206-X, enrolled with the CPF/MF under nº 140.264.678-05; and Christiano Ernesto Burmeister, Brazilian, married, business administrator, holder of Identity Card RG nº 3.584.868-6 - SSP/SP, enrolled with the CPF/MF under nº 568.995.138-20, all of whom with domicile at Av. Queiroz Filho, nº 1560, Bloco 5, Torre Sabiá, 3º Andar, Vila Hamburguesa, City of São Paulo, State of São Paulo - CEP 05319-000. The Members of the Board of Auditors, Messrs. Axel Erhard Brod (incumbent) and Christiano Ernesto Burmeister (alternate), were elected by the minority shareholders who have chosen to participate in the election separately, in view of the prerogative of article 161, § 4 of the Lei das S.A. [Joint-Stock Company Law].

The now elected members of the Board of Auditors received the following amounts of vote: (a) **Ricardo Florence dos Santos** (incumbent) and **José Osvaldo Bozzo** (alternate) – with appraisal of 53.11% of votes in favor, represented by 350.652.578 shares; 0.40% of votes against, represented by 2,663,935 shares; and 20.07% abstentions represented by

132,484,774 shares; **(b)** José Luiz De Souza Gurgel (incumbent) and Ely Carlos Perez (alternate) – with appraisal of 53.11% of votes in favor, represented by 350.652.578 shares; 0.40% of votes against, represented by 2,663,935 shares; and 20.07% abstentions represented by 132,484,774 shares; and **(c)** Axel Erhard Brod (incumbent) and Christiano Ernesto Burmeister (alternate) – in a separate election, with appraisal of 21.26% of votes in favor, represented by 140,385,493 shares; 0,001% of votes against, represented by 1,672,656; and 0.00021% abstentions, represented by 1,398 shares. The elected members of the Board of Auditors shall take their offices upon presentation of the respective instrument of investiture.

(IV) Approve, by majority of the shareholders in attendance with appraisal of 68.95% of votes in favor, represented by 455.269.523 shares; 4.60% of votes against, represented by 30.367.375 shares; and 0.02% of abstentions, represented by 164.389 shares, the establishment of the annual global remuneration of the Administrators, in the amount of up to R\$ 54,107,233.06 (fifty-four million one hundred seven thousand two hundred thirty-three reais and six cents) including all benefits and charges, being: (a) R\$ 45,008,316.59 (forty-five million eight thousand three hundred sixteen reais and fifty-nine cents) refer to the compensation of the Statutory Board; (b) R\$ 7,933,107.47 (seven million nine hundred thirty-three thousand one hundred seven reais and forty-seven cents) correspond to the remuneration of the Board of Directors; and (c) R\$ 1,165,809.00 (one million one hundred sixty-five thousand eight hundred nine reais) refer to the remuneration of the Board of Auditors. Such remuneration amounts refer to the period between January and December 2022.

(V) Approve, by majority of the shareholders in attendance, with appraisal of 65.15% of votes in favor, represented by 484.869.198 shares; 0,14% of votes against represented by 932,089 shares; and no abstentions, the proposed allocation of income for the fiscal year ended on the 31st of December 2021, corresponding to R\$ 2,171,650,197.74 (two billion one hundred seventy-one million six hundred fifty thousand one hundred ninety-seven reais and seventy-four cents), as follows: The proposed percentages of distribution of the annual net income adjusted by the deductions and additions foreseen in the income allocation policy of the Company, for the fiscal year ended on the 31st of December 2021, are 25% of mandatory dividend plus 33.77% of additional dividend. On the 10th of August 2021, the Company approved, in meeting of the Board of Directors, the distribution of interim dividends, pertinent to the period ended on the 30th of June 2021, in the amount of R\$ 958,388,883.85. On the 16th of December 2021, the Board of Directors also approved the distribution of interim dividends, for the period ended on the 30th of September 2021, in the amount of R\$ 830,111,400.00. Considering the interim dividends paid in the amount of R\$ 1,788,500,283.85 and proposed percentages of distribution. the Company shall make payment of additional dividends of R\$ 383,149,913.89. It is hereby registered that the additional dividends declared herein will be distributed against the annual net income adjusted by the deductions and additions provided for in the income allocation policy of the Company. The dividends will correspond to the approximate amount of R\$ 0.5770558784 per common share issued by the Company and will be paid in national currency, in a single installment, without monetary correction or interest, on the 22nd of April 2022, in accordance

with the procedures of the institution responsible for the bookkeeping of shares issued by the Company, based on the shareholding position on the 13th of April 2022. The shares of the Company will be traded "ex" dividends as of the 14th of April 2022, according to the proposed allocation presented.

VIII. Closure: There being no further business to discuss, these minutes were drawn up and, having been read and approved, signed by those in attendance.
