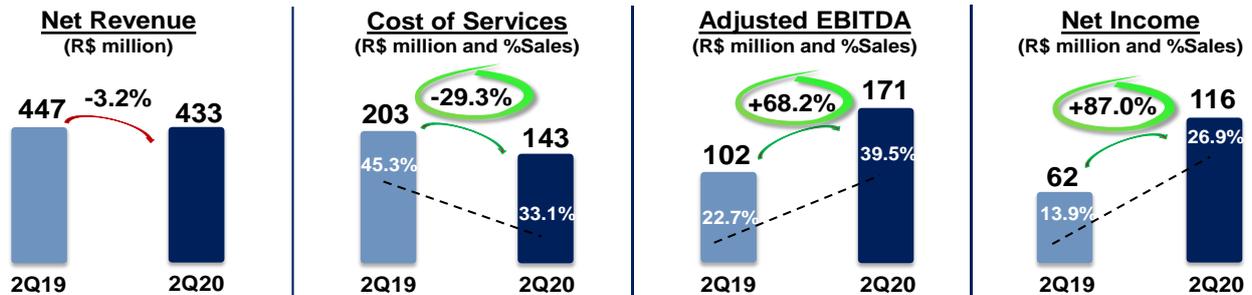


2Q20 and 6M20 Earnings Release

Sao Paulo, July 29th, 2020. OdontoPrev (B3: ODPV3.SA), the largest dental benefits company in Brazil, announced today its consolidated results for the second quarter of 2020 (2Q20). The Company's financial and operational data are presented based on consolidated numbers and in thousands of reais, except otherwise specified, pursuant to the Brazilian Corporate Law, the accounting rules of the National Health Agency (ANS) and the accounting principles of the International Financial Reporting Standards (IFRS). All information comparisons refer to variations between 2Q20, 2Q19, 6M20, 6M19, JUL19-JUN20 and JUL18-JUN19, except otherwise stated. ESG metrics on page 4.

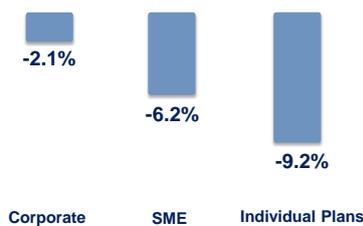
Revenues down 3.2% and Cost of Services improves 29.3%, due to Covid. Adjusted EBITDA grows 68.2%, with a margin of 39.5%, with lower G&A, selling expenses and bad debt. Net income +87% YoY, reaching R\$116 million. Cash dividends of R\$97 million. More than 5 thousand Individual Protection Equipments sent to accredited dentists free of charge.

Key metrics 2Q19 x 2Q20

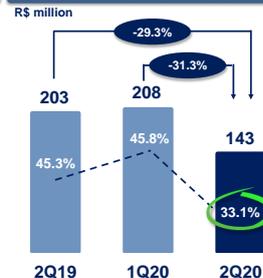


Covid-19 effects

2Q20 membership growth, per segment



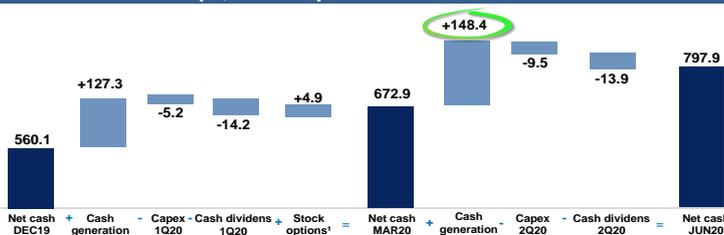
Cost of Services and Dental Care Ratio



In 2Q20, the corporate segment, more representative in the portfolio, decreased 2.1%, or 110 thousand beneficiaries QoQ. The non-corporate segment came down 6.2% in SMEs and 9.2% in Individual Plans, totaling a loss of 164 thousand lives QoQ, due to the pandemic.

The loss ratio, of 45% in the last two quarters, improved to 33% in 2Q20, given the lower frequency of consultations and services provided in the period.

The cash flow in the semester came from R\$127 million in 1Q20 to R\$148 million in 2Q20, bringing the net cash position from R\$560 million in December to R\$798 million in June. The 2Q20 total cash dividends equal R\$97 million.

The national footprint dentist network was also quickly adjusted to provide 24/7 services for those clients in need of urgent dental care, or emergency treatments, in the vast majority of the 2,700 municipalities, throughout Brazil, of our 7 million beneficiaries.

In 2Q20, over 5,000 Personal Protection Equipments (PPE's) were delivered to accredited dentists free of charge.

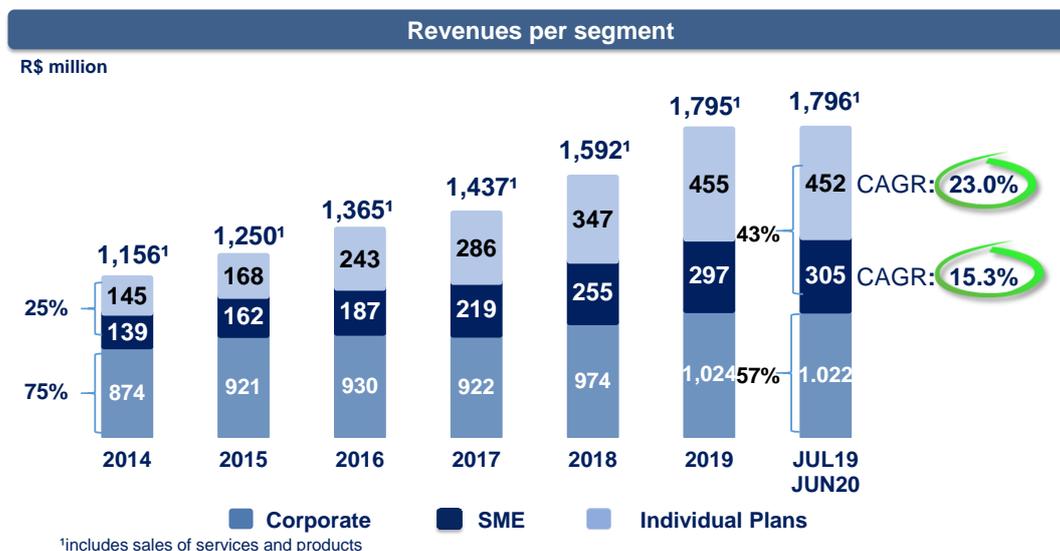
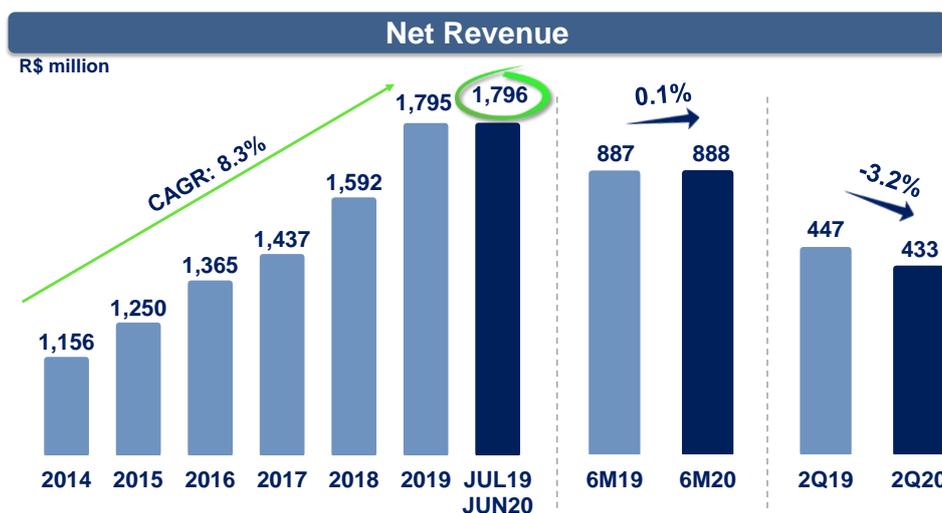

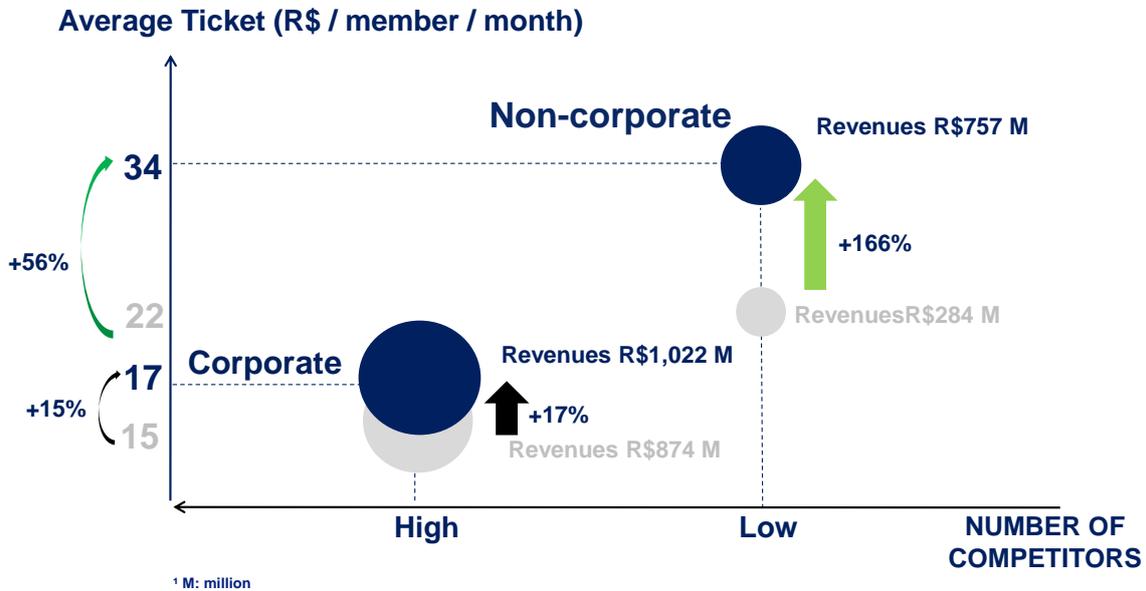
Revenues and average ticket evolution per segment since 2014



Since 2014, the non-corporate revenues, of SMEs and Individual Plans, represented a CAGR of 20%, coming from 25% to 43% of total revenues in the last twelve months, increasing the average ticket, lowering the dental care ratio and optimizing the Company's exclusive distribution banking channels, in more attractive market niches.

JUL19-JUN20 x 2014



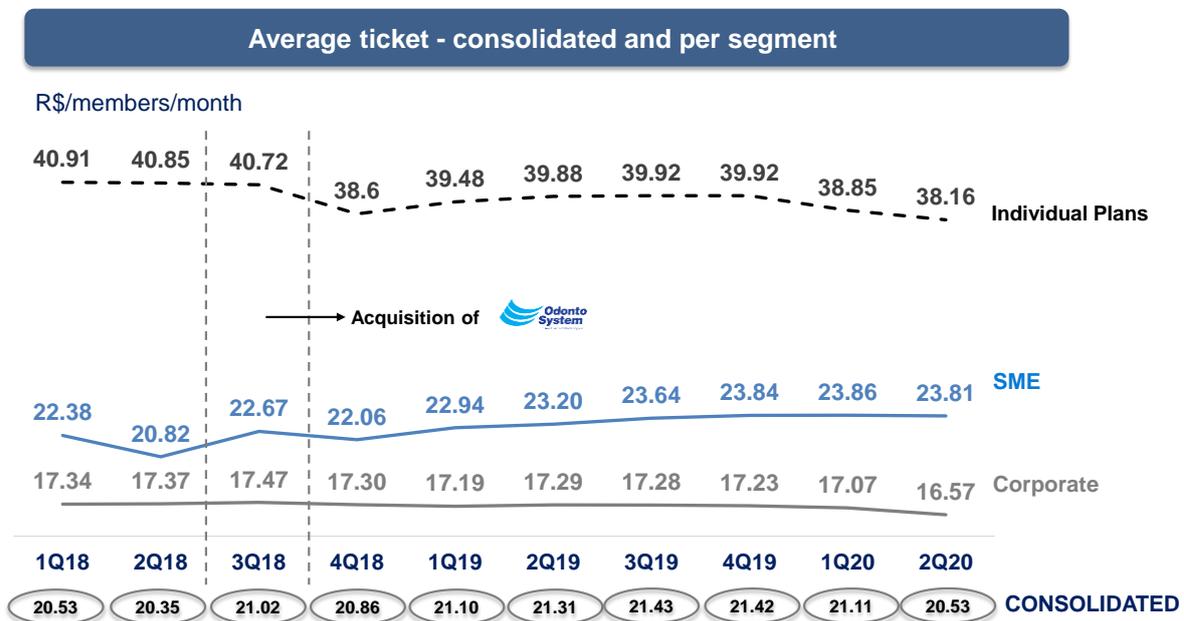

The average ticket in 2Q20 was R\$20.53, 3.6% lower YoY, due to the sales mix, corporate segment stability, higher participation of SME plans and the new portfolio of individual plans, with decreasing share of the less profitable retail channels. In the semester, the average ticket was R\$21.07.

OdontoPrev reached 7,189,206 members, with a net loss of 274 thousand beneficiaries in the quarter, of which 106 thousand in May, the lower point of the period.

The portfolio remained stable in the last twelve months, with net adds of 110 thousand corporate members and a decrease of 108 thousand non-corporate lives.

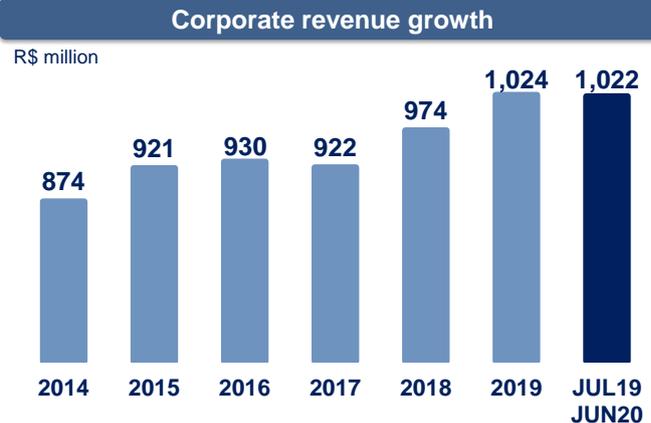

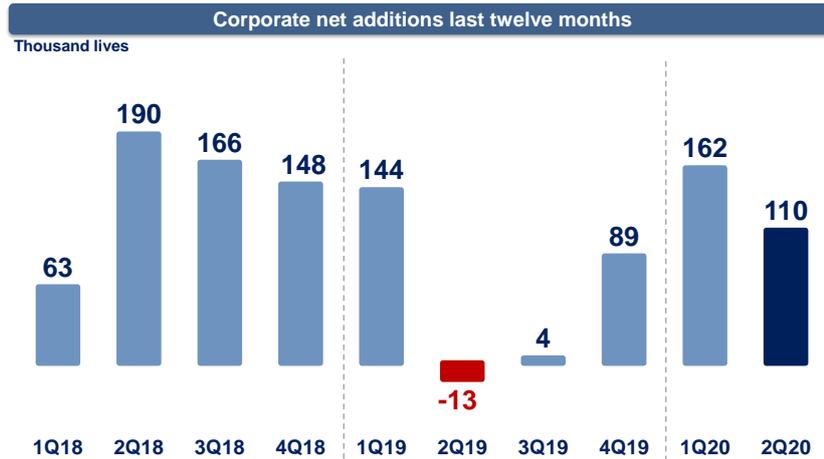

Cost of services – Corporate segment

The cost of services in the corporate segment was R\$78,263 in 2Q20, with a dental care ratio of 31.5%. In the semester, the dental care ratio was 39.4%, versus 49.2% in the same period of last year.

Selling expenses – Corporate segment

The selling expenses in the corporate segment were R\$18,626 in 2Q20, 7.5% of revenues, above the 6.5% of 2Q19.

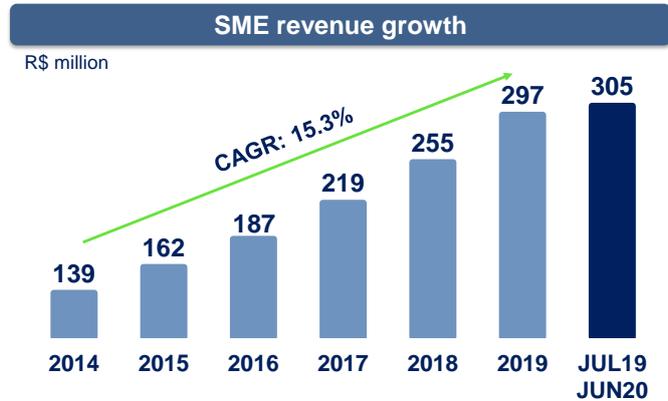

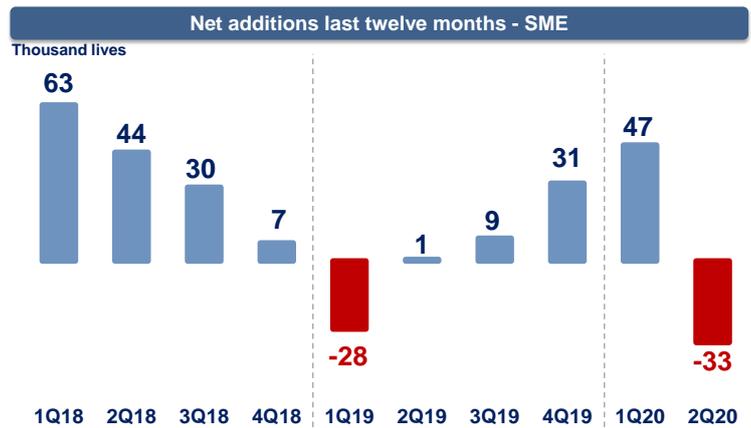

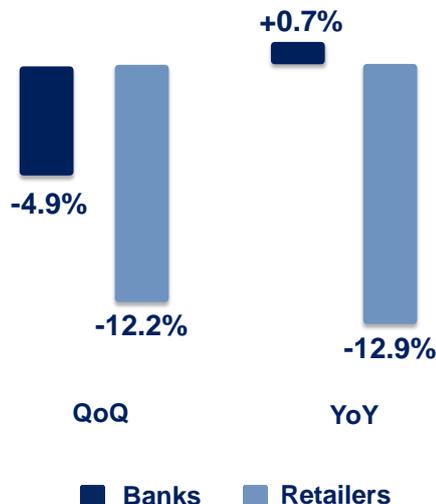

2Q20 Individual portfolio growth (%)

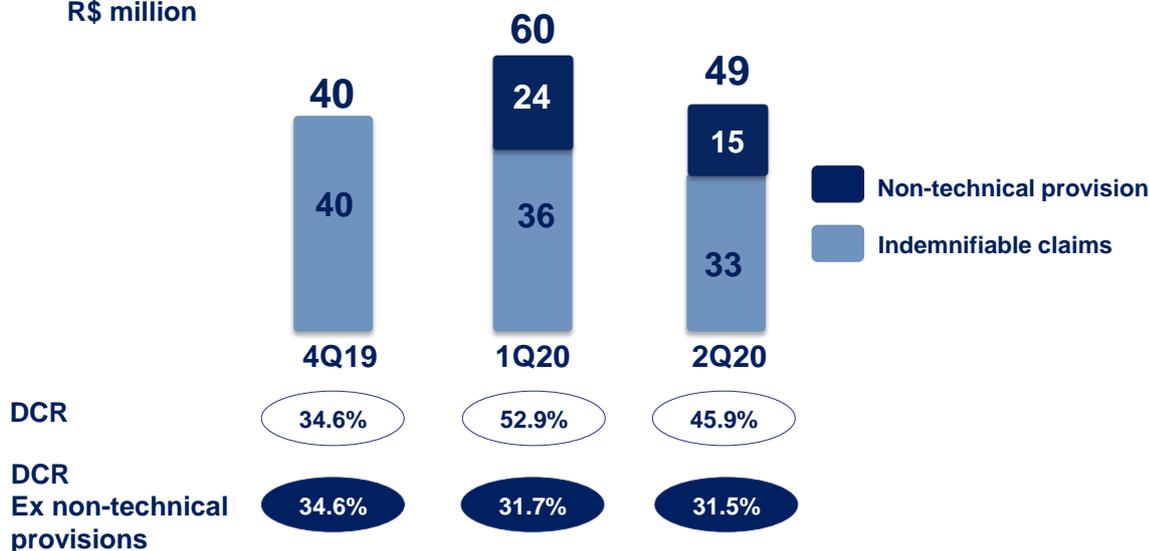

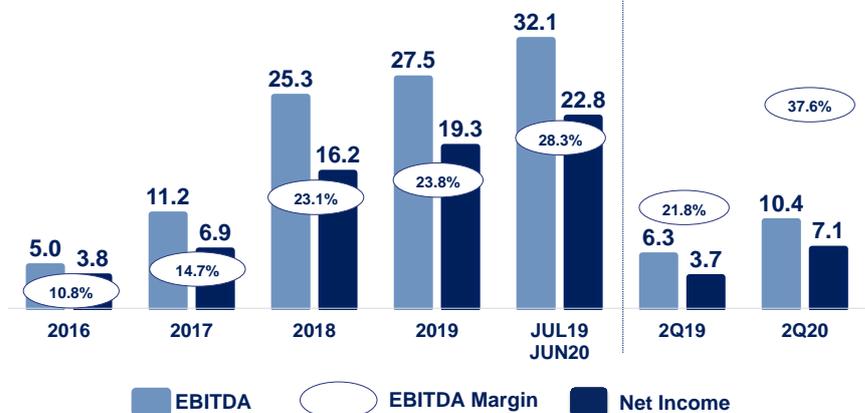

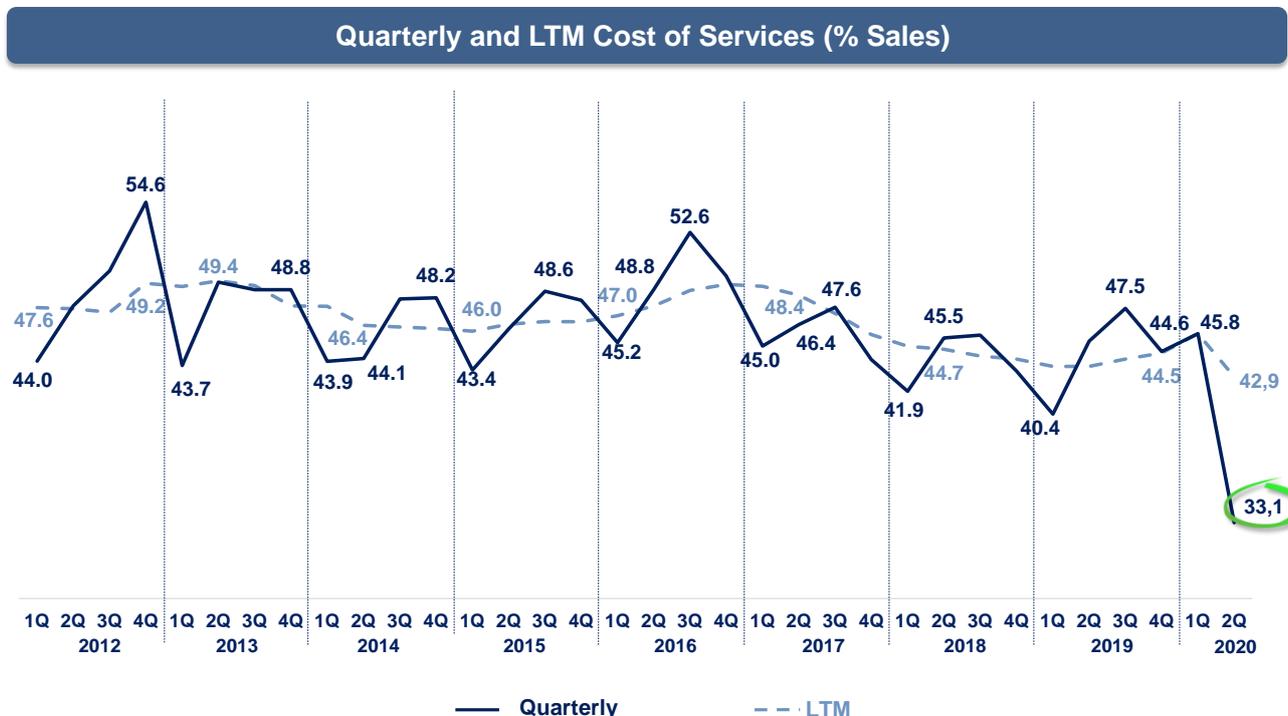

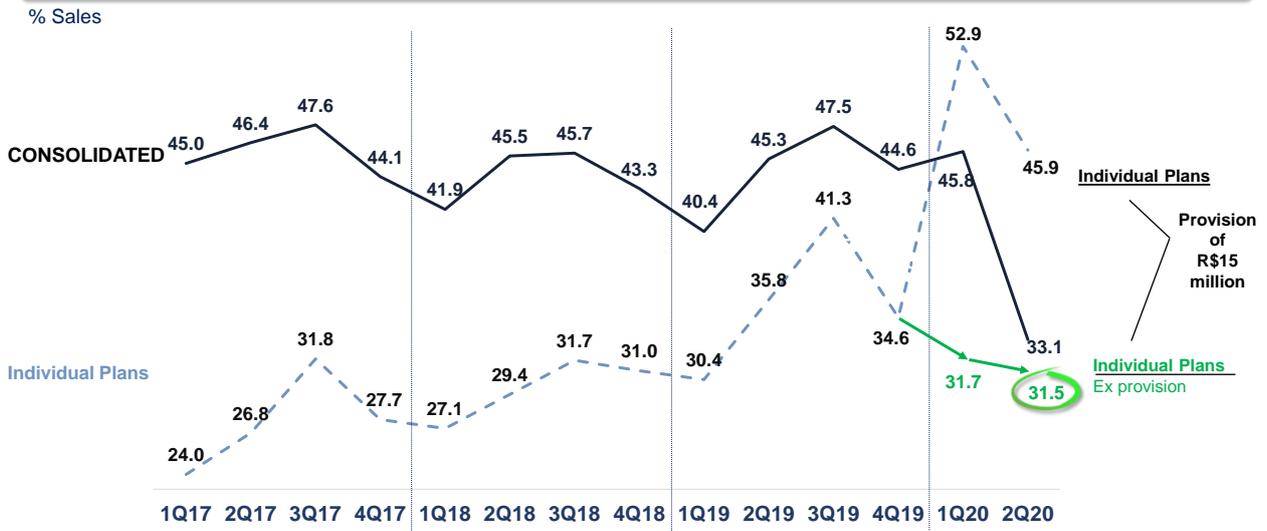

Quarterly Dental care ratio consolidated and individual plans

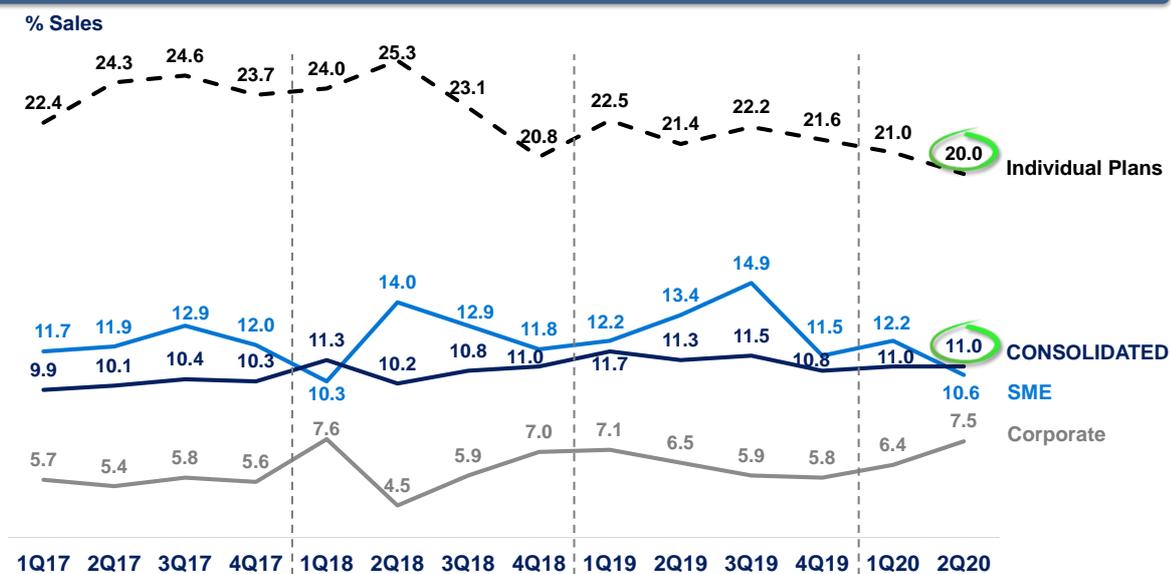

Selling expenses consolidated and per segment





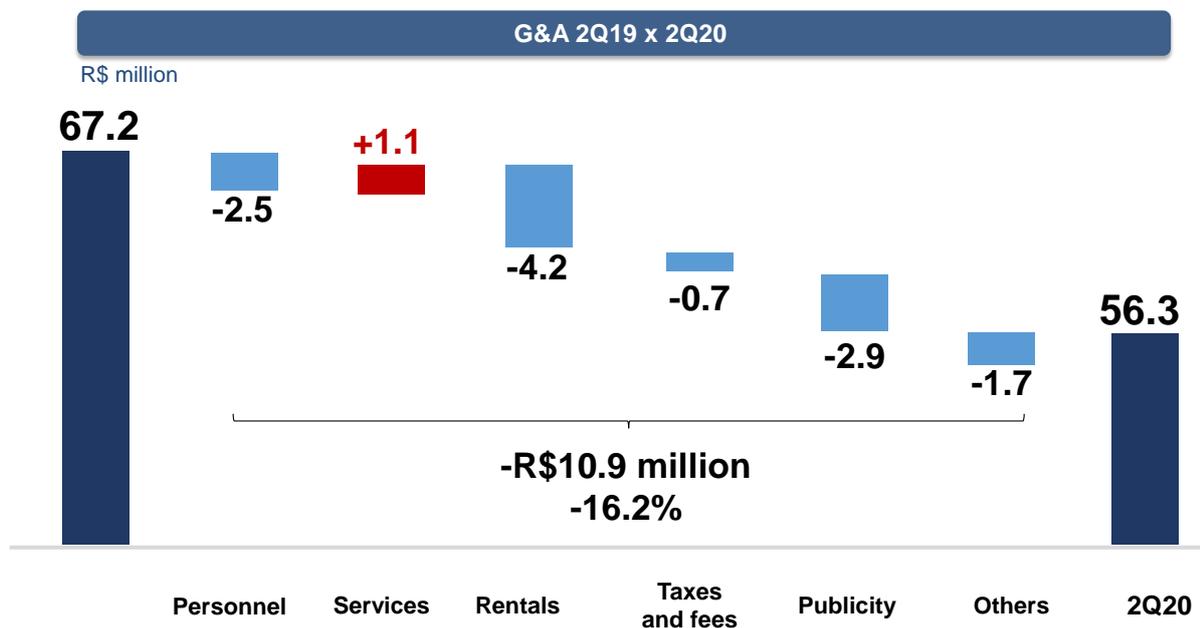

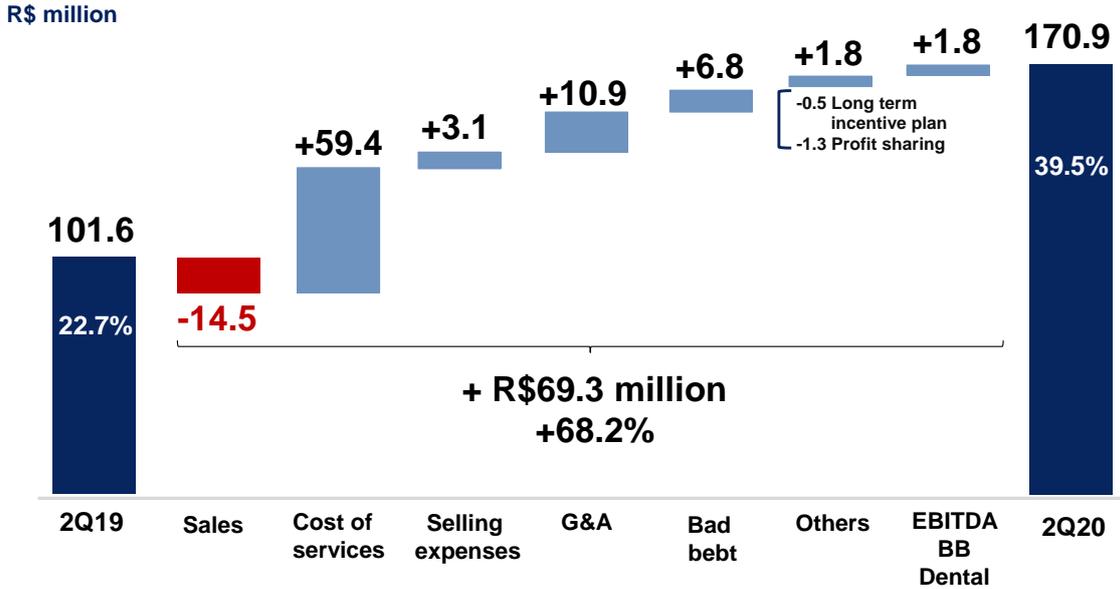

Adjusted EBITDA: 2Q20 x 2Q19



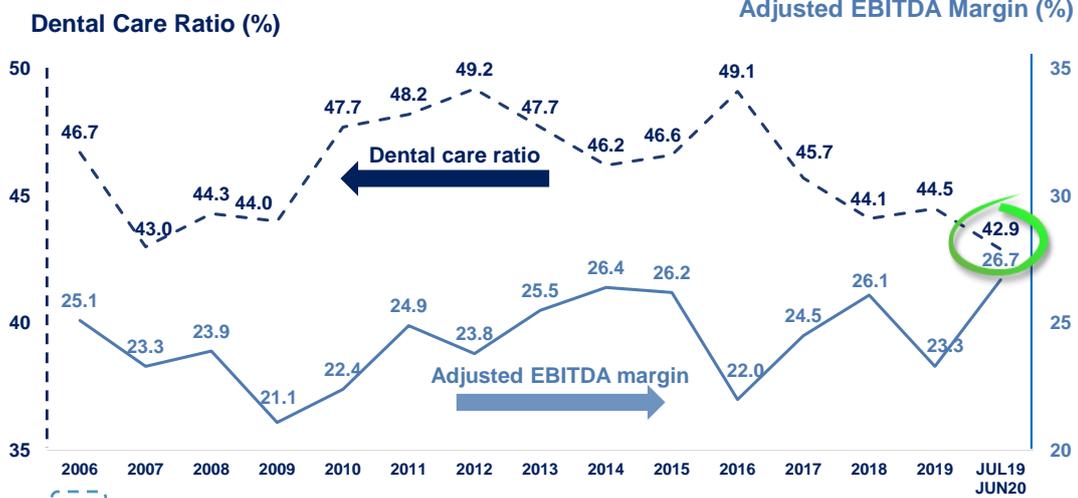
Adjusted EBITDA

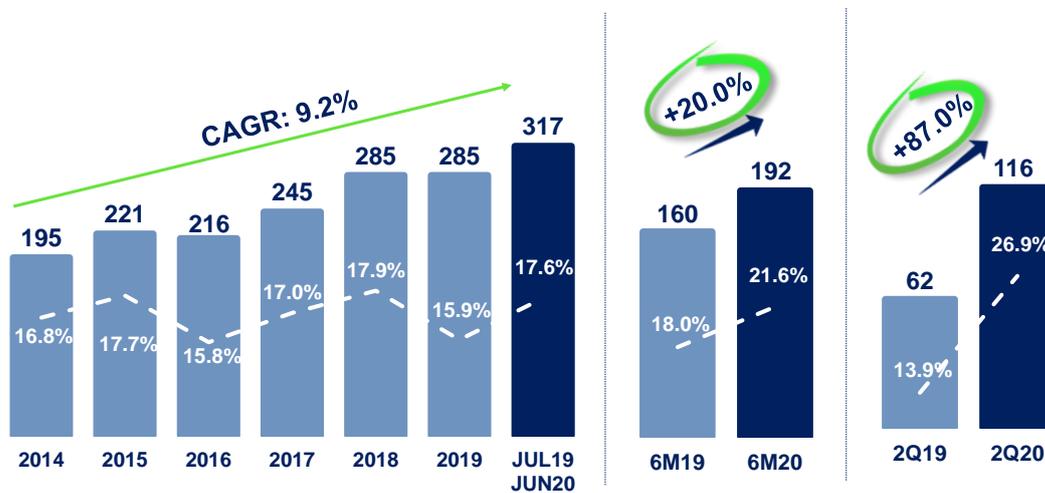

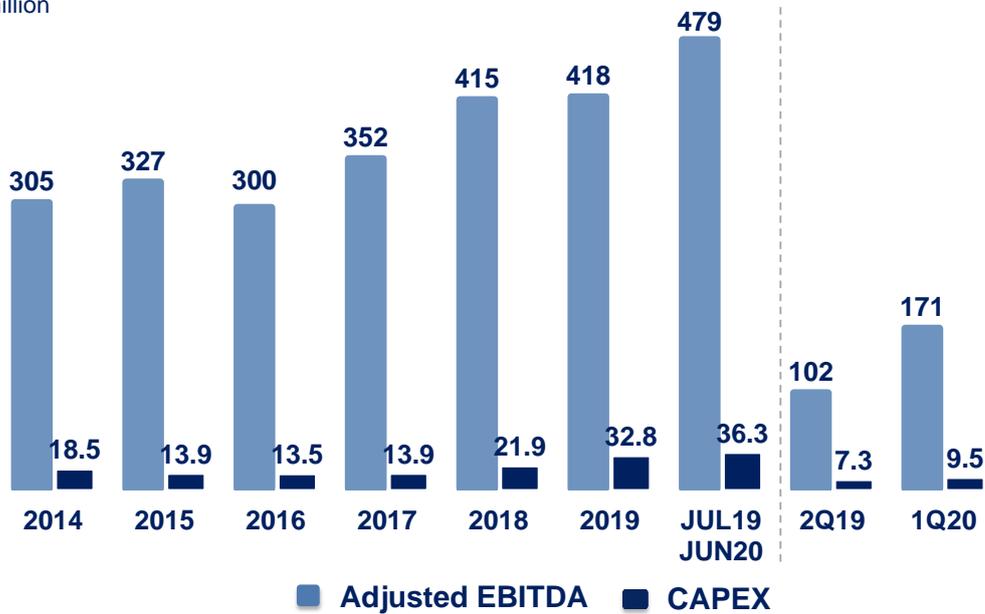

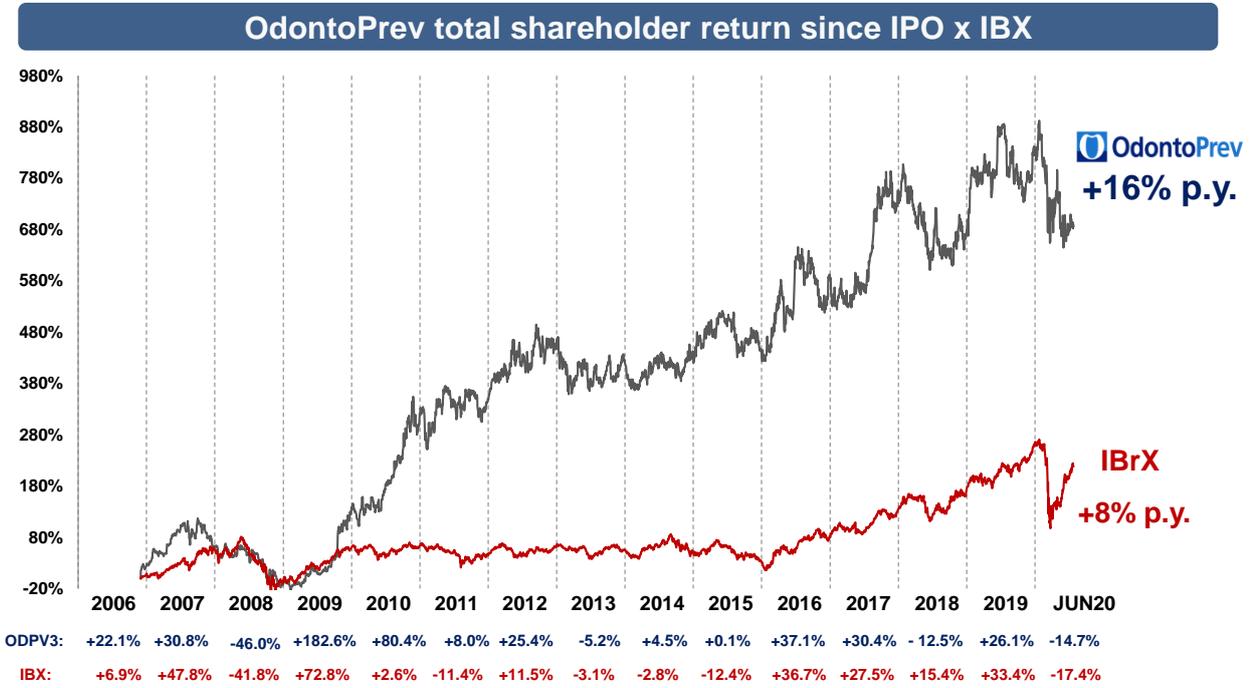

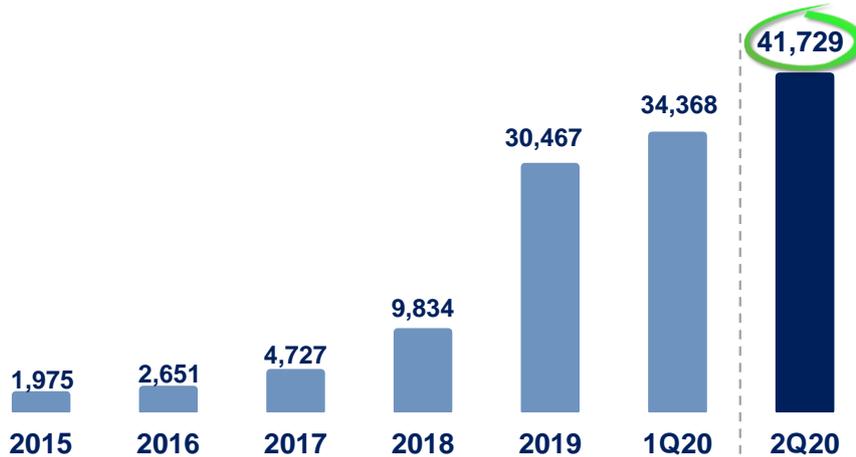

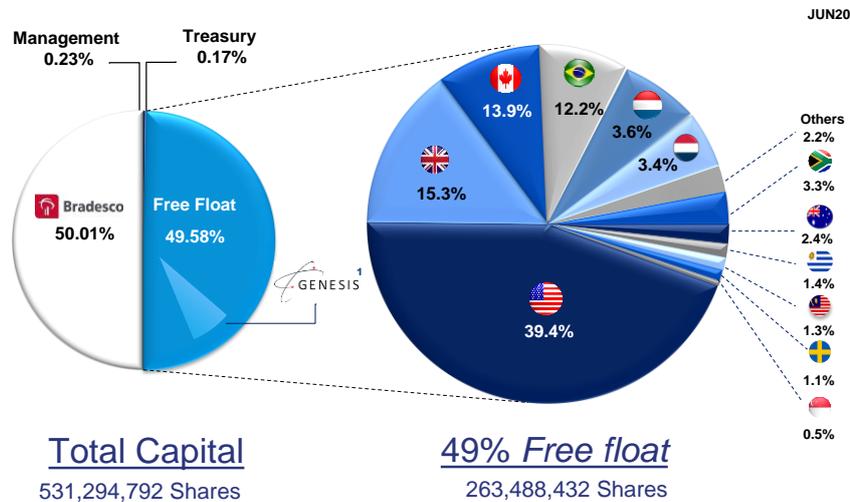

Increasing number of individual investors



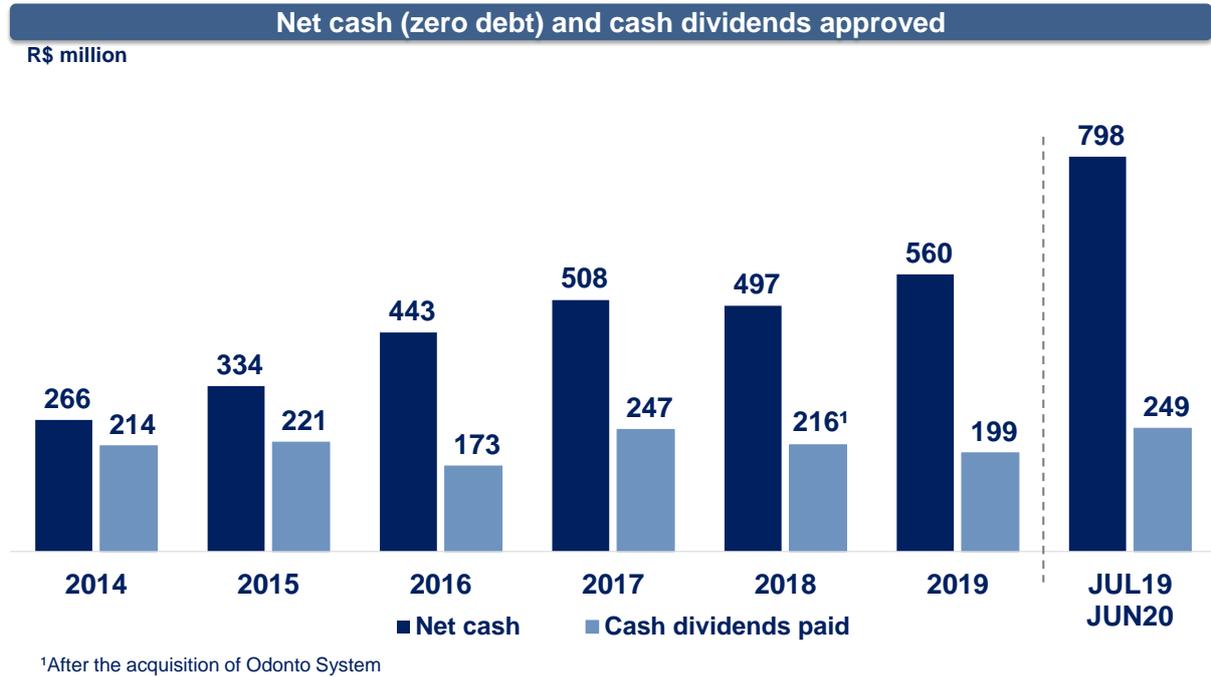
Global shareholder structure: investors from more than 30 countries



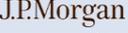
