**MINUTES OF THE ANNUAL GENERAL MEETING
HELD ON MARCH 31st, 2026**

- 1. Day, Time and Place:** March 31st, 2026, at 02:00 pm, in an exclusive digital manner, through the ALFM Easy Voting electronic platform ("Platform"), being consider held at Odontoprev S.A.'s ("Company") headquarters, located at Alameda Araguaia, 2104, 21st floor, Alphaville, ZIP Code 06455-000, in Barueri city, São Paulo State, in accordance with CVM Resolution No 81/22 ("CVMR 81").
- 2. Call notice:** (i) Call Notice published on March 02nd, March 03rd and March 04th, 2026 on Valor Econômico, on pages E9, E2 and E2, respectively; and (ii) Financial Statements published on March 02nd, 2026 on Valor Econômico, summarized physical version, pages E7 to E8, and in full digital version via the link <https://valor.globo.com/valor-ri/central-de-resultados/>. The documents required by CVM Resolution 80/2022 ("CVMR 80"), and CVMR 481 were also disclosed to the market electronically.
- 3. Attendance:** Company shareholders representing approximately 74.25% at the Annual General Meeting, as evidenced on (i) summary voting map, consolidating the remote votes, published on March 30th, 2026, by the Company; and (ii) by the presence registered on the electronic platform, under the terms of art. 47, item III, of CVMR 81. Also Mr. Ivan Luiz Gontijo Junior, Vice-Chairman of the Board of Directors, Mr. Elsen Carvalho, Chief Executive Officer, and other members of the Management; all the members of the Company's Fiscal Council; Mr. César Suaki dos Santos, Coordinator of the Audit Committee and the other members of the Audit Committee; and Mr. Claudio Sertorio and Mr. Luciano Vecchi, representatives of KPMG Independent Auditors.
- 4. Instatement:** Chairman: Ivan Luiz Gontijo Junior; Secretary: André Chidichimo de França.
- 5. Agenda:** (i) Management's account, exam, discuss and vote the Company's and Financial Statements regarding the fiscal year ended December 31, 2025, (ii) To approve the Management's proposal of destination of the net income for the fiscal year ended December 31, 2025; (iii) To fix the value limit of the annual global remuneration of the Management; (iv) To elect the effective and alternate members of the Board of Directors for the next term, as well as the appointment of the Chairman and Vice Chairman of the Board of Directors; (v) to fix the cap on the total annual compensation of the Company's directors for the 2026 fiscal year; (vi) to fix the number of members to serve on the Audit Committee for the next term; (vii) electing the standing and alternate members of the Audit Committee for the next term; and (viii) setting the compensation for the members of the Audit Committee for the next term.
- 6. Resolutions:** After examining and discussing the matters on the Agenda, the following resolutions were taken:

(i) At the Annual General Meeting:

1. It was examined, discussed and approved, by the majority votes of the attending shareholders, with 393,153,298 of votes in favor, 332,381 of opposing votes, and registered 11,253,005 abstentions, the Management Account, and Financial Statements regarding the fiscal year ended on December 31st, 2025;
2. It was approved, by unanimity of votes of the attending shareholders, represented by 404,671,238 of votes in favor, 2,440 of opposing votes, and registered 65,006 abstentions, the Proposal for the destination of 2025 net income, after legal deductions for Provision for Income Tax and Social Contributions, corresponding to the amount of R\$550,458,455.32 (five hundred and fifty million, four hundred and fifty-eight thousand, four hundred and fifty-five reais and thirty-two centavos), to be allocated as follows:

(i) R\$ 27,522,922.77 (twenty-seven million, five hundred twenty-two thousand, nine hundred twenty-two reais and seventy-seven centavos), as Legal Reserve;

(ii) The gross amount of R\$ 105,368,939.40 (one hundred and five million, three hundred and sixty-eight thousand, nine hundred and thirty-nine reais and forty centavos) distributed as interest on equity by resolution of the Board of Directors, equivalent to the net amount of R\$ 89,563,598.50 (eighty-nine million, five hundred sixty-three thousand, five hundred ninety-eight reais and fifty centavos), as declared by the Board of Directors at meetings held on (a) March 19, 2025, in the gross amount of R\$ 24,749,241.16 (twenty-four million seven hundred forty-nine thousand two hundred forty-one reais and sixteen centavos), equivalent to a net amount of R\$ 21,036,854.99 (twenty-one million thirty-six thousand eight hundred fifty-four reais and ninety-nine centavos); (b) June 18, 2025, in the gross amount of R\$ 26,016,246.09 (twenty-six million sixteen thousand two hundred forty-six reais and nine centavos), equivalent to the net amount of R\$ 22,113,809.18 (twenty-two million one hundred thirteen thousand eight hundred nine reais and eighteen centavos); (c) September 15, 2025, in the gross amount of R\$ 26,849,742.32 (twenty-six million eight hundred forty-nine thousand seven hundred forty-two reais and thirty-two centavos), equivalent to a net amount of R\$ 22,822,280.97 (twenty-two million, eight hundred twenty-two thousand, two hundred eighty reais and ninety-seven centavos); and (d) December 15, 2025, in the gross amount of R\$ 27,753,709.83 (twenty-seven million seven hundred fifty-three thousand seven hundred nine reais and eighty-three centavos), equivalent to a net amount of R\$ 23,590,653.36 (twenty-three million five hundred ninety thousand six hundred fifty-three reais and thirty-six centavos);

The amounts distributed above were imputed, net of income tax at source, when applicable, to the mandatory dividends relating to the 2025 fiscal year, pursuant to Article 9, paragraph 7, of Law No. 9,249/95, CVM Resolution No. 143/2022, and Article 29, paragraph 5, of the Company's Bylaws.

(iii) The amount of R\$ 338,154,830.66 (three hundred thirty-eight million, one hundred fifty-four thousand, eight hundred thirty reais and sixty-six centavos) distributed as interim dividends by resolution of the Board of

Directors, as stated by the Board of Directors at meetings held on (a) May 6, 2025, in the amount of R\$ 118,000,000.00 (one hundred eighteen million reais); (b) August 5, 2025, in the amount of R\$ 115,154,830.66 (one hundred fifteen million, one hundred fifty-four thousand, eight hundred thirty reais and sixty-six centavos); and (c) December 15, 2025, in the amount of R\$ 105,000,000.00 (one hundred five million reais); and

- (iv) The amount of R\$79,411,762.49 (seventy-nine million, four hundred and eleven thousand, seven hundred and sixty-two reais and forty-nine centavos) retained in the investment and expansion reserve, pursuant to Article 28, paragraph 3(d) of the Bylaws.
3. It was approved by unanimity of votes of the attending shareholders, represented by 404,622,362 of votes in favor, 8,024 opposing votes, and 68,298 abstentions, the establishment of the number of members that will compose the Board of Directors, of 8 (eight) effective members and 3 (three) alternate members.
4. The following was approved by a majority vote of the shareholders present, with 339,796,949 votes in favor, 58,663,941 votes against, and 6,277,794 abstentions recorded: the election of the slate composed of the following members to the Company's Board of Directors, with a unified term of office until the Annual General Meeting that approves the financial statements for the fiscal year ending December 31, 2027:

The appointment of Mr. Luiz Carlos Trabuco Cappi and Mr. Ivan Luiz Gontijo Junior to the positions of Chairman and Vice Chairman of the Board of Directors, respectively, was also approved, pursuant to Article 16 of the Company's Bylaws.

The members of the Board of Directors, both regular and alternate, shall assume their respective positions within thirty (30) days from this date, following the signing of their respective Letters of Appointment, which shall be recorded in the Company's Board of Directors' Minutes Book. The directors hereby elected have declared, under penalty of law, that they meet all the requirements set forth in Article 147 of the Brazilian Corporations Law, in RCVM 80, and in Normative Resolution (RN) No. 520, dated April 29, 2022, of the National Supplementary Health Agency (ANS), for their appointment as members of the Company's Board of Directors.

Mrs. César Suaki dos Santos and Murilo César Lemos dos Santos Passos (effective members), and **Mr. José Mauro Depes Lorga** (alternate member) are considered independent directors, as defined in Annex K of CVMR 80 and Novo Mercado Regulations of B3 S.A. – Brazil, Bolsa, Balcão, pursuant to the Management Proposal, with the minimum percentage required in the Regulation being met.

5. It was approved by the majority of votes of the attending shareholders, represented by 373,682,788 of votes in favor, 30,984,654 of opposing votes, and 71,242 abstentions, the limit of the annual global remuneration of management of up to R\$37,500,000.00 (thirty-seven million five hundred thousand reais), contemplating in this amount the pro-labore, the benefits, the bonuses and the long-term incentives, as well as the remuneration of the Fiscal Council approved in accordance with item 8 below;
6. It was approved, by unanimous votes of the attending shareholders, represented by 404,642,236 votes in favor, 7,116 of opposing votes, and 89,332 abstentions being counted, the establishment of the number of members that will compose the Fiscal Council, of 3 (three) effective members and 3 (three) alternate members.
7. The following was approved by a majority vote of the shareholders present, with 404,259,120 votes in favor, 336,425 votes against, and 143,139 abstentions

recorded: the election of the slate composed of the following members to the Company's Fiscal Council, with a unified term of office until the Ordinary General Meeting that approves the financial statements for the fiscal year ending December 31, 2026:

The elected members, declared, under penalty of law, that meet all the requirements of Article 162 of Lei das S.A. as Company's Fiscal Council member.

8. It was approved by the majority of votes of the attending shareholders, represented by 398,501,478 votes in favor, 20,994 of opposing votes, represented by and 6,216,212 abstentions, to fix the Fiscal Council remuneration for the fiscal year of 2026, of R\$540,000.00 (five hundred thousand reais), within the limit provided for in art. 162, §3, of the Brazilian Corporation Law.

CLOSURE: There being no further business to discuss, and as no one of the attendees wished to speak, the meeting was closed, drawing up these minutes in summary form, which may be published with the omission of the signatures of the attending shareholders, pursuant to Article 130 of the Brazilian Corporation Law, which was read, found to be in compliance and signed by as many shareholders as are sufficient for the validity of the minutes, in terms of Article 130 of Brazilian Corporation Law.
