**NOTICE OF CAPITAL INCREASE APPROVED BY THE BOARD OF DIRECTORS**  
*(Pursuant to Exhibit 30-XXXII of Brazilian Securities and Exchange Commission’s Normative Ruling No. 480/09)*

On June 30<sup>th</sup>, 2021 at 10:00 am, the Board of Directors verified the issuance of new common shares, within the authorized capital limit, as a result of the exercise by certain beneficiaries of options granted (i) by *Companhia de Bebidas Das Américas – AmBev*, on November 25<sup>th</sup>, 2011 and November 12<sup>th</sup>, 2012, and received by the Company under the Migration Program approved by the Board of Directors on July 31<sup>st</sup>, 2013, within the scope of the Company’s Stock Option Plan approved by the Shareholders’ General Meeting held on July 30<sup>th</sup>, 2013 (“Stock Option Plan”), and (ii) by the Company, under the terms of the programs approved by the Board of Directors on December 2<sup>nd</sup>, 2013, December 1<sup>st</sup>, 2014, December 1<sup>st</sup>, 2015 and December 22<sup>nd</sup>, 2015, all under the Stock Option Plan.
