ADR Program

Rio de Janeiro, April 16, 2025.

Vibra Energia S.A. (“Companhia”) (B3: VBBR3) in compliance with the provisions of CVM Resolution No. 44, of August 23, 2021, hereby informs its shareholders that it has started to sponsor an American Depositary Receipt issuance program backed by common shares issued by the Company (“ADR” and “ADR Program”, respectively), with the following main characteristics:

- depository institution of the ADRs: JPMorgan Chase Bank, N.A.;
- composition of the ADRs: each ADR subject to issuance under the ADR Program will be backed by 2 (two) common shares issued by the Company;
- trading of the ADRs: the ADRs will be admitted to trading on the over-the-counter market;
- trading code: the ADRs will be represented by the ticker “VBREY”.

Investors wishing to receive ADRs must, through their brokers, in compliance with the terms and conditions of the Deposit Agreement and applicable legal and regulatory provisions, contact JPMorgan Chase Bank, N.A.

The Company will keep its shareholders and the market in general informed about the ADR Program, in accordance with applicable laws and regulations.
