Artisan Partners Limited Partnership ("Artisan Partners"), on behalf of certain of its clients, as investment manager, informs you that it has acquired common shares issued by Focus Energia Holding Participacoes SA ("Company"). As of July 30, 2021, Artisan Partners holds an aggregate of 4,736,700 common shares, which represents 5.28% of the total common shares issued by the Company.

Artisan Partners requests the Investor Relations Officer of the Company to disclose, as deemed necessary by the Company, to the Securities and Exchange Commission of Brazil and to the other relevant authorities the following information:

- a. Artisan Partners is headquartered at 875 East Wisconsin Avenue, Suite 800, Milwaukee, WI 53202, USA;
- b. the equity interests held by Artisan Partners in aggregate are 4,736,700 common shares, representing approximately 5.28% of the total common shares issued by the Company as noted above;
- c. Artisan Partners does not hold convertible debentures issued by the Company;
- d. the equity interests are held strictly for investment purposes, not aiming to change the control of the controlling interest or the Company's management structure; and
- e. Artisan Partners has not entered into any contracts or agreements regulating the exercise of voting rights or the purchase and sale of securities issued by the Company.
- f. The legal representatives of Artisan Partners' clients in Brazil, for purposes of Article 119 of Law 6,404, of December 15, 1976, as amended, is Citibank Distribuidora de Títulos e Valores Mobiliários SA, CNPJ No. 33.868.597/00001-40.
