## NOTICE TO THE MARKET 2024 ANNUAL INTEGRATED REPORT

**TOTVS S.A.** (B3: TOTS3) ("TOTVS" or "Company") hereby informs its shareholders and the market that on this date published the tenth (10<sup>th</sup>) annual edition of its Integrated Report and the Reference Form ("FRE"), both related to the fiscal year 2024.

The Integrated Report reinforces TOTVS' commitment to transparency, guided by the continuous evolution of our sustainability strategy, in addition to marking a decade of the Company's positioning.

To prepare it, TOTVS followed the guidelines of the International Integrated Reporting Council (IIRC), as well as the methodology of the Global Reporting Initiative – GRI Standards, the largest international reference for sustainability reports, complemented by the SASB Standards, specific to the Software and IT Services industry.

In this edition, we expanded the scope of the 4<sup>th</sup> greenhouse gas emissions inventory, including new acquired companies and, for the first time, submitted the material to an independent external verification, adding even more rigor and reliability to the process.

We reinforced our commitment to human development by adopting the *Educa 2030* and *Mente em Foco* commitments, associated with the UN's 2030 Agenda.
