## NOTICE TO THE MARKET 2021 ANNUAL INTEGRATED REPORT

TOTVS S.A. (B3: TOTS3) ("TOTVS" or "Company") hereby informs its shareholders and the market that on this date it published the sixth (6<sup>th</sup>) annual edition of its Integrated Report, related to the fiscal year 2021.

This report is a voluntary accountability and communication with our stakeholders, in line with our philosophy and transparency and commitment to promoting positive change through the connection of business, people and technology, which include sustainability as a value proposition.

For its preparation, TOTVS followed the methodology of the Global Reporting Initiative - GRI Standards: Essential option - the greatest international standard for sustainability reports, as well as the guidelines of the International Integrated Reporting Council (IIRC). Its content also integrates our commitment to the evolution of the 10 (ten) principles of the United Nation Global Compact, to which we have been signatories since 2014, and our contributions to achieving the Sustainable Development Goals (SDGs).

As another important step in the development of the ESG Agenda, in the Environmental pillar, for the first time we incorporated greenhouse gas emissions data in the report, in accordance with the Carbon Disclosure Project (CDP) report model. In the Social pillar, we reinforced initiatives to implement an Agenda focused on flexible work model, mental health, diversity and inclusion, education and partnerships. Finally, in the Governance pillar, we highlight the risk matrix review, GDPR initiatives and the conclusion of the ESG thematic committees implementation. Additionally, in this edition, the report was submitted to external verification, conducted by independent auditors, in order to assess the report's adherence to the GRI and IIRC aspects and guidelines.
