
Market projections estimated revenue less than ¾ of what was actually achieved by the Management BU.

The 5-10 year CAGR of Management BU grows 1.2x more than the market itself, which in turn grows 2x the Nominal GDP.







ADJUSTED EBITDA (R\$ million)






ARR - Net Addition

ADJUSTED EBITDA (R\$ million)












Revenue Net of Funding grew 26%, and Adjusted Net Income was 5.6x higher than in 1Q24
