MATERIAL FACT

PAYMENT OF INTEREST ON EQUITY

TOTVS S.A. (B3: TOTS3) ("Company" or "TOTVS") hereby informs that the Board of Directors, in a meeting held on this date, approved the payment of interest on equity in the gross total amount of R\$129,388,152.74 (one hundred twenty-nine million, three hundred eighty-eight thousand, one hundred fifty-two reais and seventy-four cents), corresponding to R\$0,22 (twenty-two cents) per share of the Company ("Shares"), which shall be attributed to the mandatory dividends of the fiscal year.

The payment of interest on equity will be subject to the following conditions:

1. All shareholders registered as such on December 3rd, 2024 shall be entitled to receive the interest on equity; **2.** The Shares will be traded "ex-rights" as of December 4th, 2024, inclusive; **3.** The interest on equity will be paid to the beneficiary shareholders on December 27th, 2024, without the incidence of currency correction or remuneration whatsoever, at the bank account and banking domicile, as informed to Banco Itaú Unibanco S.A.; **4.** Shareholders whose registration is incomplete or outdated will only have their rights credited after the updating of such information with Banco Itaú Unibanco S.A.; **5.** Shareholders who hold their Shares under a fiduciary custody arrangement shall have their proceeds available according to procedures adopted by B3 S.A. – Brasil, Bolsa, Balcão; **6.** The amount of the interest on equity is subject to withholding income tax, according to the applicable law; and **7.** Shareholders immune or exempt of withholding income tax shall send to the Company the documents attesting such condition, until December 13th, 2024, to the following address: Avenida Braz Leme, 1000, Casa Verde – Zip Code: 02511-000 – São Paulo - SP – Phone: +55 (11) 99585-7887, to the Investor Relations Department.
