## NOTICE TO THE MARKET ACQUISITION OF EXACT SALES BY RD STATION

**TOTVS S.A.** (B3: TOTS3; the "<u>Company</u>" or "<u>TOTVS</u>") hereby announces that its subsidiary, RD Gestão e Sistemas S.A. ("<u>RD Station</u>"), on this date, entered into an Agreement for the Sale and Purchase of Shares and Other Covenants (the "<u>Agreement</u>") to acquire the entire capital stock of Exact Desenvolvimento e Programação de Software S.A. ("<u>Exact Sales</u>") for the amount of R\$51 million. In addition, subject to compliance with certain conditions, the Agreement provides for the payment of a complementary purchase price.

Exact Sales, a leading company in the Sales Engagement segment, offers solutions aimed at prospecting and qualifying companies' potential customers (prospects). Founded in 2015, Exact Sales serves both startups and large companies, and in recent years has made two major acquisitions that complement its offerings: "Resultys" in 2020, with the scope of Searching, with offers a B2B contact base for prospecting, expanding the options for its customers; and Magic Write, earlier this year, focused on artificial intelligence for content production, such as texts for social networks and ads. These features combined result in a differentiated portfolio that aims to boost the conversion rates of sales teams, reducing negotiation cycles and the Cost of Customer Acquisition, especially when combined with the CRM (Customer Relationship Management). With about 1,250 clients and 230 employees, Exact Sales has earned net revenue of approximately R\$25 million over the past 12 months, with a CAGR of 31% over the past 3 years.

This movement reinforces RD Station positioning as a central pillar of TOTVS' strategy in the construction of the largest and most complete Business Performance ecosystem in Brazil, focused on the digitalization of the customer's sales funnel. This digitalization is a growing demand in a market that is still fragmented in terms of solutions, and with this acquisition, RD Station takes another step in building a complete portfolio for the marketing and sales universe, which enables the optimization of end-to-end processes, generating more efficiency and results for Brazilian SMEs.
