MINUTES OF THE ANNUAL GENERAL MEETING HELD ON APRIL 30, 2024

1. DATE, TIME AND PLACE: On April thirty, twenty twenty-four, at 3:00PM, the Annual General Shareholders' Meeting of BB Seguridade Participações S.A. ("BB Seguridade" or "Company"), was held on first call, at the company's headquarters at Setor de Autarquias Norte, Quadra 5, Bloco B, 3° andar, Torre Sul, Asa Norte - Brasília (DF).

The meeting was held exclusively digitally, as authorized by Law 6.404/1976, Art. 124, § 2-A, and CVM Instruction No. 81/2022, Art. 28, § 3. The digital platform provided by the Company meets the requirements set forth in Art. 28, § 2, of CVM Instruction No. 81/2022.

- **2. BOARD AND OTHERS PRESENT**: The works were referred, in accordance with Art. 8, § 2, of the Articles of Incorporation of BB Seguridade, by the Chairman of the Board of Directors, Mr. Kamillo Tononi Oliveira Silva, who, when setting up the Meeting, invited to join the board:
 - a) the shareholder, Ms. Mariana Figuerôa Bretas Chiari, to act as Secretary; and
 - b) Dr. Leonardo Elisei de Faria, as a representative of Banco do Brasil, controlling shareholder of BB Seguridade.

They were present at the General Meeting, as provided for in Articles 134, § 1, and 164 of Law 6.404/1976, and in Art. 28, § 5, of CVM Instruction No. 81/2022:

- a) Dr. Lucineia Possar, Chairman of the Supervisory Board of BB Seguridade;
- b) Mr. Roberto Kenedi, representative of Deloitte Touche Tohmatsu Auditoria Independente;
- c) Mr. Luiz Cláudio Moraes, Coordinator of the Audit Committee; and
- d) Dr. Ricardo Demétrio Loricchio, Company lawyer.
- **QUORUM, READING OF DOCUMENTS AND INFORMATION:** The number of shareholders present remotely, by themselves or by proxy, and those who cast their vote remotely at the Annual General Meeting of BB Seguridade, was six hundred and fourteen (614), holding one billion, five hundred and ninety-three million, six hundred and eighty-eight thousand, eight hundred and ninety-three (1,593,688.893) common shares, representing seventy-nine integers and sixty-eight hundredths percent (79.68%) of the total two billion common shares, excluding treasury shares.

The Company registered the receipt, between 03.28.2024 and 04.24.2023, of six hundred and three (603) remote ballots for the Annual General Meeting, which were duly computed,



as shown in the Final Voting Map published on BB Seguridade's Investor Relations website (https://www.bbseguridaderi.com.br/).

The list of shareholders who attended the General Meeting, via the Digital Platform and via the Remote Ballot, can be found in Annex 1.

The Chairman of the Meeting reminded the shareholders present that, in accordance with the provisions of Article 48, § 4, of CVM Resolution 81/2022, the Consolidated Voting Map was made available for consultation on BB Seguridade's Investor Relations website, as well as on the Digital Platform of the Meeting. That said, the reading of the Consolidated Map of the votes cast by means of remote ballots was thus waived. The reading of the matters on the agenda and of the respective documents submitted for discussion and voting was also waived, pursuant to Article 134, head provision, of Law No. 6.404/1976.

The shareholders present were informed that the Meeting was being fully recorded, in accordance with the procedures set forth in Article 75, item IV, of CVM Resolution No. 81/2022.

As participation in the Meeting was exclusively digitally, the Chairman informed the shareholders of the rules and procedures adopted for the meeting and for using the Digital Platform.

- **4.** <u>CALL:</u> The matters presented to the Meeting were those contained in the Call Notice published on March 28th and April 1st and 2nd in the Correio Braziliense newspaper, physical and digital copies (Caderno Cidades page 17, Caderno Cidades page 14 and Caderno Cidades page 15, respectively) and on BB Seguridade's Investor Relations and the Brazilian Securities Commission ("CVM") websites, pursuant to the legislation in force.
- **PUBLICATIONS:** The Management Report, the Financial Statements, the Deloitte Touche Tohmatsu's Opinion, the Supervisory Board's Opinion and the Audit Committee's Report Summary were published on February 5th, 2024 in the Correio Braziliense newspaper, physical and digital versions (in a specific section).
- 6. AGENDA: The shareholders of the Company gathered to examine, discuss and vote on the following agenda of the Annual General Meeting: I- To elect the members of the Board of Directors to fulfill the 2023/2025 term; II- To elect the members of the Supervisory Board for the 2024/2026 term; III- To take the directors' accounts, examine, discuss and vote on the financial statements, opinions of the Supervisory Board and independent auditors, and note of the Management Report, related to the fiscal year ended on 12.31.2023; IV- To resolve on the allocation of the net profit for the fiscal year 2023 and the distribution of dividends; and V- To set the annual overall compensation for the members of the Company's management bodies; VI- To set the compensation of the members of the Company's Board of Directors; VII- To set the compensation of the members of the Company's Supervisory Board; VIII- To set the compensation of the members of the Company's Risks and Capital



Committee; and X- To set the compensation of the independent member of the Related-Party Transactions Committee.

7. RESOLUTIONS:



- V. approved, by majority of votes (according to the detailed final voting chart), the global amount for the payment of fees and benefits of the members of the Executive Board and the Board of Directors of BB Seguridade, under the terms of the proposal presented by the controlling shareholder, Banco do Brasil S.A., at the time of the Meeting, in accordance with the statement of the Secretariat for the Coordination and Governance of State-Owned Enterprises ("Sest"), object of SEI Technical Note No. 13204/2024/MG, and considering the 4.62% readjustment, to set them in the amount of up to R\$ 9,632,597.48 (nine million, six hundred and thirty-two thousand, five hundred and ninety-seven reais and forty-eight centavos), for the period from April 2024 to March 2025.

- VII. approved, by a majority of votes (according to the detailed final voting map), the amount of up to R\$242,491.14 (two hundred and forty-two thousand, four hundred and ninety-one reais and fourteen cents) for the total remuneration to be paid to the members of the Fiscal Council, for the period from April 2024 to March 2025. It set the individual monthly fees of its members at one tenth of the average monthly remuneration received by the members of the Executive Board, excluding amounts related to additional vacation and benefits, which corresponds to R\$ 6,735.87 (six thousand, seven hundred and thirty-five reais and eighty-seven cents) per month, for the period from April 2024 to March 2025.
- VIII. approved, by a majority of votes (according to the detailed final voting map), the amount of up to R\$1,013,006.75 (one million, thirteen thousand, six reais and seventy-five cents) for the total remuneration to be paid to the members of the Audit Committee, for the period from April 2024 to March 2025. It set the individual monthly fees of its members at 16.71% of the average monthly remuneration received by the members of the Executive Board, excluding the amounts related to vacation bonuses and benefits, which corresponds to R\$ 11,255.63 (eleven thousand, two hundred and fifty-five reais and sixty-three cents) per month, for the period from April 2024 to March 2025.
 - **IX.** approved, by a majority of votes (according to the detailed final voting map), the amount of up to R\$405,202.70 (four hundred and five thousand, two hundred and two reais and seventy cents) for the total remuneration to be paid to the members of the Risk and Capital Committee, for the period from April 2024 to March 2025. It set the individual

monthly fees of its members at 16.71% of the average monthly remuneration received by the members of the Executive Board, excluding amounts related to additional vacation and benefits, which corresponds to R\$ 11,255.63 (eleven thousand, two hundred and fifty-five reais and sixty-three cents) per month, for the period from April 2024 to March 2025.

X. approved, by a majority of votes (according to the detailed final voting map), the amount of up to R\$135,067.57 (one hundred and thirty-five thousand, sixty-seven reais and fifty-seven cents) for the total remuneration to be paid to the independent member of the Related Party Transactions Committee, for the period from April 2024 to March 2025. It set the member's individual monthly fees at 16.71% of the average monthly remuneration received by members of the Executive Board, excluding amounts related to additional vacation and benefits, which corresponds to R\$ 11,255.63 (eleven thousand, two hundred and fifty-five reais and sixty-three cents) per month, for the period from April 2024 to March 2025.

Records: In addition to the voting guidelines set out above, the controlling shareholder, Banco do Brasil S.A., reiterated Sest's guidelines, which were the subject of SEI Technical Note 13204/2024/MGI, regarding the remuneration of the members of BB Seguridade's statutory bodies, as follows:

- a) the payment of any item of compensation not resolved at the meeting to statutory members, including benefits of any kind and representation fees, is forbidden, pursuant to Article 152 of Law 6.404, of December 15, 1976;
- b) it is the responsibility of the Board of Directors, with the support of the Internal Audit and the Statutory Audit Committee, to ensure compliance with the overall and individual limits of the compensation of statutory members set in the general meeting;
- c) the payment of the variable compensation (RVA) of officers is subject to strict compliance with the terms and conditions of the programs previously approved by Sest/MGI:
- d) the recommendation to apply reversal on deferred portions of variable compensation programs from previous years that have not yet been paid is maintained in cases where, considering the recurring net profit for the fiscal year 2023, there is a drop of more than 20% compared to the years used as basis when carrying out the programs, in accordance with current legislation.
- e) it is forbidden to pass on, to the directors, any benefits that may be granted to the company's employees when the collective bargaining agreement is formalized on its respective base date;
- f) it is the responsibility of federal state-owned companies to verify the regularity of the payment of social charges that are the employer's responsibility, including through legal analysis;



- g) in situations where the officer is also an employee of the federal state-owned company, their employment contract must be suspended (Precedent No. 269 of the Superior Labor Court);
- h) the payment of the item quarantine is subject to the approval of the Public Ethics Commission of the Presidency of the Republic CEP/PR, pursuant to current legislation;
- i) the payment of the housing allowance is subject to compliance with budget laws and the implementation of internal regulations approved by the Board of Directors; and
- j) the effective payment of the supplementary pension plan benefit is subject to compliance with the provisions of Article 202 § 3, of the Constitution and Article 16 of Supplementary Law No. 109, of May 29th, 2001, which prohibit offering the benefit to an exclusive group of employees and legally equivalent individuals and the contribution of resources to a private pension entity, except as a sponsor, in which case, under no circumstances, may its normal contribution exceed that of the policyholder.

Clarifications:

As clarified during the Meeting, the remuneration approved in items VI to X, submitted to the shareholders, was calculated based on the average monthly remuneration received by the members of the Executive Board, including the Christmas bonus and excluding amounts relating to vacation bonuses and benefits.

Pursuant to Article 47, §§ 1 and 2, of CVM Instruction No. 81/2022, shareholders who attended through the Digital Platform and remote ballot are considered signatories of these minutes and the Shareholders' Attendance book, and their registration in the minutes was made by the President and by the Secretary of the Meeting.

Pursuant to Article 9, sole Paragraph, of BB Seguridade's Articles of Incorporation, the minutes of the General Shareholders' Meeting shall be drawn up in summary form with regard to the facts that occurred, including dissents and protests, and contain the transcription only of the resolutions taken, observing the legal provisions.

- **8.** <u>CLOSING</u>: At the end of the resolutions, Mr. Kamillo Tononi Oliveira Silva thanked everyone for their presence and adjourned the Annual General Meeting of BB Seguridade Participações S.A., of which I, Mariana Figuerôa Bretas Chiari, Secretary, had these Minutes drawn up in summary form, as set forth in Article 130, § 1, of Law 6.404/76, which, after being read and found compliant, is duly signed.
