### HOLDERS' MEETING OF THE NON-AMORTIZABLE ORDINARY PARTICIPATION CERTIFICATES

#### "VOLARIS.CPO"

Pursuant to the provisions of Articles 218, 219, 221, and 228 and other applicable articles of the General Law on Negotiable Instruments and Credit Transactions (*Ley General de Títulos y Operaciones de Crédito*), and in accordance with Irrevocable Trust Agreement No. 80676 dated September 11, 2013 (the "Trust Agreement" or the "Trust"), as well as the indenture dated September 11, 2013 (as amended from time to time, the "Indenture") of the non-amortizable ordinary participation certificates with identification ticker "VOLARIS.CPO" (the "CPOs"), issued by Nacional Financiera, Sociedad Nacional de Crédito, Institución de Banca de Desarrollo, Dirección Fiduciaria, in its capacity as trustee under the Trust, where Controladora Vuela Compañía de Aviación, S.A.B. de C.V. acts as settlor (the "Settlor"), and Banco Invex, S.A., Institución de Banca Múltiple, Invex Grupo Financiero, acts as common representative (the "Common Representative") of the CPO holders (the "Holders"), the Holders are hereby summoned to attend the Holders' Meeting to be held on July 13, 2026, at 4:00 p.m. (the "Meeting"), at the offices of the Common Representative, located at Blvd. Manuel Ávila Camacho, No. 40, 8th floor, with entrance on the 9th floor, Colonia Lomas de Chapultepec I Sección, Mexico City, Alcaldía Miguel Hidalgo, Zip Code 11000, in order to consider the matters set forth in the agenda below; it being understood that capitalized terms used herein, other than proper nouns, titles, or words at the beginning of a sentence, that are not expressly defined herein shall have the meanings ascribed to them in the Trust Agreement and/or the Indenture, as the context may require:

- II. Appointment of delegates to formalize and give effect to the resolutions adopted by the Meeting.
