**MINUTES OF THE MEETING OF THE STATUTORY AUDIT COMMITTEE

1. **Date, Time and Place:** Held on March 25, 2026, at 9:00 a.m., exclusively digitally, being considered held at the headquarters of Azul S.A. ("Company"), located in the City of Barueri, State of São Paulo, at Avenida Marcos Penteadó de Ulhôa Rodrigues, nº 939, 8th floor, Jatobá Building, Castelo Branco Office Park Condominium, Tamboré, CEP 06460-040.
2. **Call and Attendance:** The meeting was duly convened in accordance with Article 4.1 of the Internal Regulations of the Statutory Audit Committee (or simply "Audit Committee"), and, in view of the presence of the totality of the members of the Audit Committee.
