The Company further clarifies that, in compliance with art. 4, sole paragraph, of CVM Resolution 44/2021, questioned its managers and controlling shareholders as to the existence of relevant acts or facts capable of justifying the fluctuations, and they confirmed that they were not aware of information in this regard.
