

NEXA RESOURCES PROVIDES UPDATE ON VAZANTE OPERATION

Luxembourg, January 12, 2022 - Nexa Resources S.A. ("Nexa Resources" or "Nexa" or the "Company") (NYSE: "NEXA") informs that the underground operation of Vazante has reduced today its daily production to 60% of its capacity due to heavy rainfall levels in the state of Minas Gerais.

As a result, Vazante's underground mine has received more water than it could pump to the surface, partially flooding the lower levels of the mine. The Extremo Norte underground mine has not been affected and continues to operate. Production has not yet been impacted month to date.

Nexa is taking all the necessary measures, focusing on the precautions to ensure the safety of its employees and host communities. The mine is safe, and its entire structure was designed and built to withstand this type of natural risk.

The Company continues to monitor the rainfall scenario in Minas Gerais and believes that all of its dams are safe and monitored 24 hours a day, seven days a week by the Dam Safety Management System ("SIGBAR"). SIGBAR includes video cameras, periodic inspections, support from specialized external consultants and monitoring with instruments and water level meters, among other important indicators that contribute to the dams' continuous stability.

Nexa is closely monitoring the situation and is already planning the resumption of operations in the affected areas when it becomes possible to do so, as the rainfall is expected to stop in the coming days. The potential impact on Vazante's monthly production is under review and Nexa will keep the market informed of further developments.

Nexa is a large-scale, low-cost integrated zinc producer with over 60 years of experience developing and operating mining and smelting assets in Latin America. Nexa currently owns and operates five long-life underground mines - three located in the Central Andes of Peru and two located in the state of Minas Gerais in Brazil - and is developing the Aripuanã Project as its sixth underground mine in Mato Grosso, Brazil. Nexa also currently owns and operates three smelters, two located in Brazil and one in Peru, Cajamarquilla, which is the largest smelter in the Americas. Nexa was among the top five producers of mined zinc globally in 2021 and also one of the top five metallic zinc producers worldwide in 2021, according to Wood Mackenzie.
